

Inflation in Brief

1. **CPI inflation General**, increased to 38.0% on year-on-year basis in May 2023 as compared to an increase of 36.4% in the previous month and 13.8% in May 2022. On month-on-month basis, it increased to 1.6% in May 2023 as compared to an increase of 2.4% in the previous month and an increase of 0.4% in May 2022.
2. **CPI inflation Urban**, increased to 35.1% on year-on-year basis in May 2023 as compared to an increase of 33.5% in the previous month and 12.4% in May 2022. On month-on-month basis, it increased to 1.5% in May 2023 as compared to an increase of 2.0% in the previous month and an increase of 0.3% in May 2022.
3. **CPI inflation Rural**, increased to 42.2% on year-on-year basis in May 2023 as compared to an increase of 40.7% in the previous month and 15.9% in May 2022. On month-on-month basis, it increased to 1.7% in May 2023 as compared to an increase of 3.0% in the previous month and an increase of 0.6% in May 2022.
4. **SPI inflation** on YoY increased to 43.0% in May 2023 as compared to an increase of 42.1% a month earlier and 14.1% in May 2022. On MoM basis, it increased by 1.3% in May 2023 as compared to an increase of 2.7% a month earlier and an increase of 0.6% in May 2022.
5. **WPI inflation** on YoY basis increased to 32.8% in May 2023 as compared to an increase of 33.4% a month earlier and an increase of 29.6% in May 2022. On MoM basis, it increased by 1.0% in May 2023 as compared to an increase of 0.1% a month earlier and an increase of 1.4% in corresponding month of last year i.e. May 2022.




Figure 2: Rural Inflation - YoY, Special Indices

6. Figures 1 and 2 show graphically the yearly data of Table 1.a for Urban and Rural CPI while Table 1.1 shows "Period Average" and "YoY" percent changes in indices of three years.

Core inflation (NFNE)

7. Measured by **non-food non-energy Urban** increased to 20.0% on (YoY) basis in May 2023 as compared to an increase of 19.5% in the previous month and 9.7% in May 2022. On (MoM) basis, it increased by 1.2% in May 2023 as compared to an increase of 1.8% in previous month, and an increase of 0.7% in corresponding month of last year i.e. May, 2022.
8. Measured by **non-food non-energy Rural** increased to 26.9% on (YoY) basis in May 2023 as compared to an increase of 24.9% in the previous month and 11.5% in May 2022. On (MoM) basis, it increased by 2.5% in May 2023 as compared to an increase of 2.7% in previous month, and an increase of 0.9% in corresponding month of last year i.e. May 2022.

Core inflation (Trimmed)

9. Measured by 20% **weighted trimmed mean Urban** increased to 30.5% on (YoY) basis in May 2023 as compared to 28.6% in the previous month and 10.7% in May 2022. On (MoM) basis, it increased by 1.5% in May 2023 as compared to an increase of 1.5% in the previous month and an increase of 0.8% in corresponding month of last year i.e. May 2022.
10. Measured by 20% **weighted trimmed mean Rural** increased to 38.8% on (YoY) basis in May 2023 as compared to 37.3% in the previous month and 14.1% in May 2022. On (MoM) basis, it increased to 2.0% in May 2023 as compared to an increase of 2.0% in the previous month and an increase of 1.4% in corresponding month of last year i.e. May 2022.

Figure 1: Urban Inflation - YoY, Special Indices




Figure 3: Urban Inflation - MoM, Special Indices




Figure 4: Rural Inflation - MoM, Special Indices




Figure 5: CPI YoY (National, Urban, Rural)





Figure 6: CPI MoM (National, Urban, Rural)

The **National Consumer Price Index** for **May 2023** is increased to 1.58% over **April 2023** and increased to 37.97% over corresponding month of the last year i.e. **May 2022**.

Increased: Newspapers (32.77%), Accommodation Services (22.84%), Personal Effects n.e.c.(6.82%), Stationery (5.44%), Text Books (5.15%), Washing Soap/Detergents/Match Box (4.29%), Motor Vehicle Accessories (3.86%), Plastic Products (3.2%), Electricity Charges (2.92%), Electrical Appliances for Personal (2.29%), Furniture and Furnishing (1.94%) and Construction Input Items (1.42%).

Decreased: Transport services(1.01%), Motor fuel(0.07%) and Solid Fuel(0.04%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. May, 2022 are given below:

(53.35%), Motor Vehicle Accessories (45.15%), Household Equipments (41.73%), Construction Input Items (38.07%), Motor Vehicles (38.01%), Liquified Hydrocarbons (36.17%), Newspapers (33.88%), Solid Fuel (31.84%), Cotton Cloth (31.53%), Plastic Products (28.65%), Accommodation Services (27.4%), Mechanical Services (24.73%) and Transport Services (24.13%).

III. Rural Consumer Price Index (RCPI)

The Rural Consumer Price Index for May 2023 is increased to 1.69% over April 2023 and increased to 42.18% over corresponding month of the last year i.e. May 2022.

Increased: Potatoes (25.3%), Gur (12.7%), Chicken (9.36%), Milk powder (6.6%), Eggs (6.58%), Readymade Food (4.97%), Rice (4.86%), Milk fresh (3.75%), Pulse Moong (3.64%), Tea (3.5%), Milk products (3.37%), Wheat Flour (3.37%), Meat (3.32%), Gram Whole (3.28%), Wheat Products (3.14%), Bakery and Confectionary (2.66%), Pulse Mash (2.39%), Butter (2.22%), Beans (2.2%), Beverages (2.01%), Pulse Gram (1.94%), Condiments and Spices (1.8%) and Pulse Masoor (1.15%).

Decreased: Onions (31.97%), Tomatoes (30.66%), Fresh Vegetables (18.18%), Fresh Fruits (3.13%), Sugar (1.79%), Vegetable Ghee (1.53%), Mustard Oil (1.13%) and Cooking Oil (0.89%).

NON-FOOD:

Increased: Newspapers (46.34%), Washing Soaps, Detergents and Match Box (7.52%), Personal Effects n.e.c.(6.1%), Text Books (6.08%), Mechanical Services (5.98%), Household Equipments (4.64%), Electricity Charges (2.92%), Readymade Garments (2.72%), Motor Vehicles Accessories (2.71%), Motor Vehicles (2.1%), Education (1.5%), Liquified Hydrocarbons (1.03%) and Construction Input Items (0.26%).

Decreased: Solid Fuel (0.14%) and Motor Fuels (0.04%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. May, 2022 are given below:

Increased: Cigarettes (127.23%), Potatoes (113.54%), Tea (106.35%), Wheat Flour (100.5%), Wheat (93.46%), Eggs (88.31%), Rice (86.35%), Wheat Products (81.81%), Pulse Moong (66.27%), Condiments and Spices (64.76%), Pulse Mash (64.73%), Dry Fruits (55.27%), Besan (54.37%), Fresh Fruits (52.84%), Bakery and Confectionary (50.88%), Pulse Gram (49.43%), Gram Whole (47.91%), Milk fresh (42.61%), Milk Powder (42.31%), Beans (41.47%), Sugar (40.85%), Readymade Food (38.27%), Chicken (38%), Beverages (36.93%), Gur (36.04%), Cooking Oil (28.64%) and Mustard Oil (25.9%).

Decreased: Tomatoes (39.62%) and Onions (17.7%).

NON-FOOD

Increased: Text Books (129.44%), Motor Fuels (74.92%), Washing Soaps, Detergents and Match Box (60.96%), Electricity Charges (59.28%), Personal Effects n.e.c. (59.19%), Stationery (50.95%), Newspapers (46.48%), Motor Vehicles Accessories (42.31%), Liquified Hydrocarbons (40.8%), Household Equipments (40.47%), Transport Services (37.13%), Solid Fuel (36.11%), Construction Input Items (33.19%), Mechanical Services (28.69%) and Motor Vehicles (27.71%).

IV. Sensitive Price Indicator

Quintile-wise percentage changes YoY and MoM are given below in Table 4. The series from May 2022 to May 2023 is also graphed below in Figure 7.



V. Wholesale Price Index

The Wholesale Price Index for **May, 2023** increased by 0.96% over **April, 2023**. It increased to 32.79% over the corresponding month of the last year i.e. May, 2022. YoY and MoM movements, from May, 2022 to May, 2023 are also graphed below in Figure 8.


