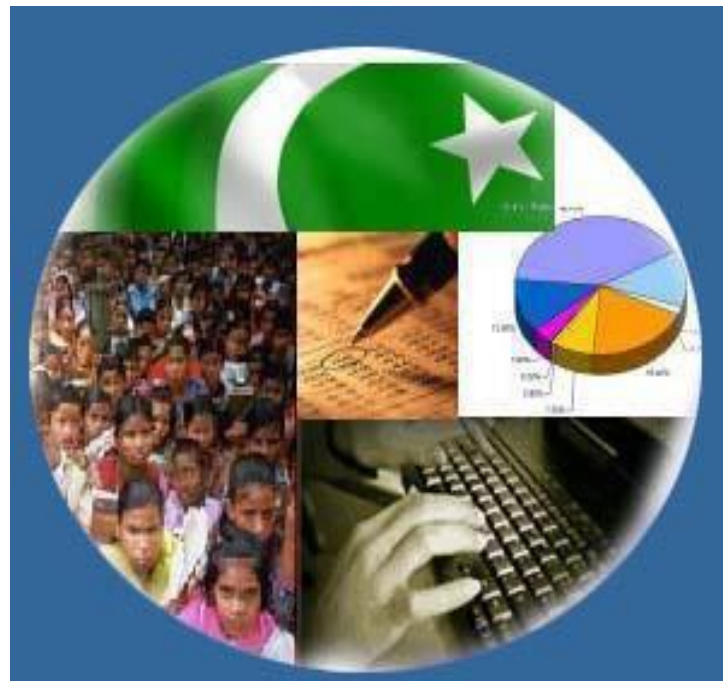

Inflation in Brief

- CPI inflation General**, decreased to 1.5% on year-on-year basis in February 2025 as compared to 2.4% in the previous month and 23.1% in February 2024. On month-on-month basis, it decreased by 0.8% in February 2025 as compared to an increase of 0.2% in the previous month and no change in February 2024.
- CPI inflation Urban**, decreased to 1.8% on year-on-year basis in February 2025 as compared to 2.7% in the previous month and 24.9% in February 2024. On month-on-month basis, it decreased by 0.7% in February 2025 as compared to an increase of 0.2% in the previous and corresponding month of last year i.e. February 2024.
- CPI inflation Rural**, decreased to 1.1% on year-on-year basis in February 2025 as compared to 1.9% in the previous month and 20.5% in February 2024. On month-on-month basis, it decreased by 1.1% in February 2025 as compared to an increase of 0.2% in the previous month and a decrease of 0.3% in February 2024.
- SPI inflation** on YoY decreased to 0.2% in February 2025 as compared to 0.7% a month earlier and 30.4% in February 2024. On MoM basis, it decreased by 1.6% in February 2025 as compared to a decrease of 1.4% a month earlier and a decrease of 0.8% in February 2024.
- WPI inflation** on YoY basis decreased to 0.7% in February 2025 as compared to 0.6% a month earlier and an increase of 18.7% in February 2024. On MoM basis, it decreased by 0.2% in February 2025 as compared to an increase of 0.2% in the previous month and 1.1% change was observed in corresponding month of last year i.e. February 2024.

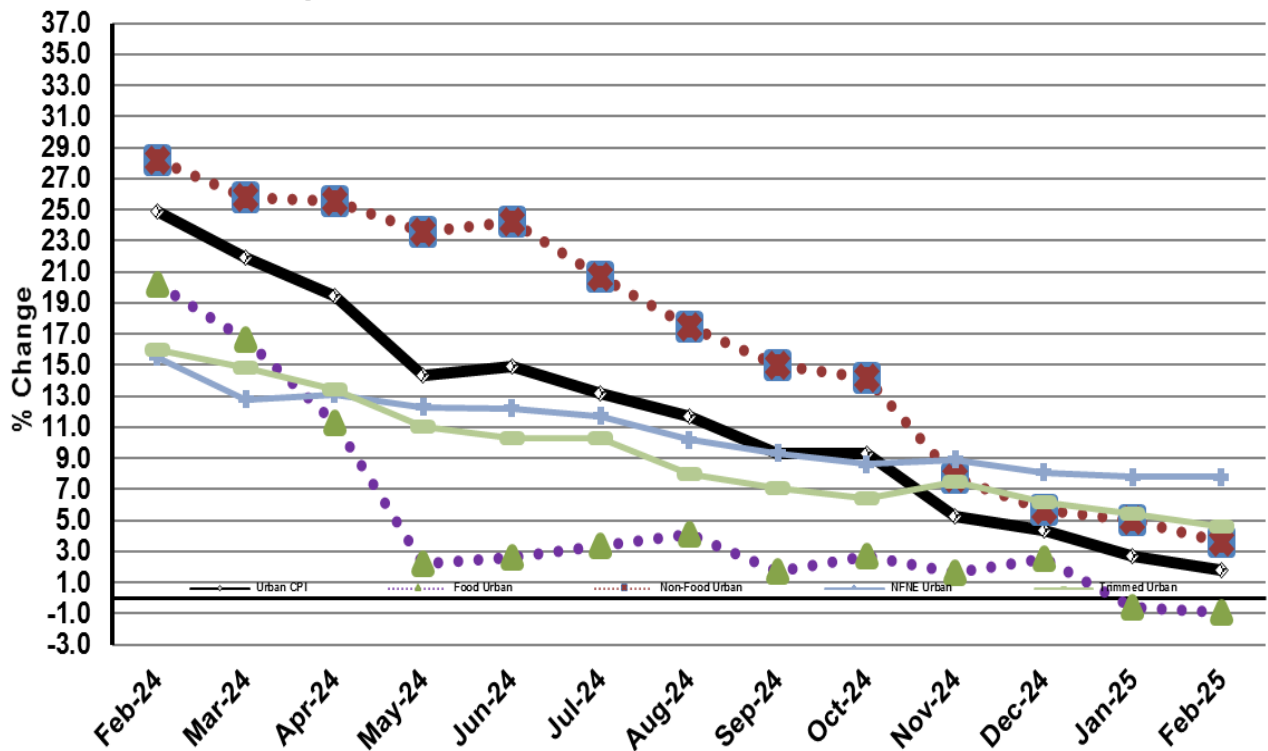


Figure 2: Rural Inflation - YoY, Special Indices

- Figures 1 and 2 show graphically the yearly data of Table 1.a for Urban and Rural CPI while Table 1.1 shows "Period Average" and "YoY" percentage changes in indices of last twenty-two months.

Core inflation (NFNE)

7. Measured by **non-food non-energy Urban** remained stable at 7.8% on (YoY) basis in February 2025 as compared to the previous month and an increase of 15.5% in February 2024. On (MoM) basis, it increased by 0.3% in February 2025 as compared to 0.8% in previous month and an increase of 0.3% in corresponding month of last year i.e. February, 2024.
8. Measured by **non-food non-energy Rural** also remained unchanged at 10.4% on (YoY) basis in February 2025 as compared to the previous month and 21.9% in February 2024. On (MoM) basis, it increased by 0.4% in February 2025 as compared to an increase of 0.9% in previous month and an increase of 0.4% in corresponding month of last year i.e. February 2024.

Core inflation (Trimmed)

9. Measured by 20% **weighted trimmed mean Urban** decreased to 4.6% on (YoY) basis in February 2025 as compared to 5.4% in the previous month and 16.0% in February 2024. On (MoM) basis, it increased by 0.1% in February 2025 as compared to an increase of 0.6% in the previous month and an increase of 0.3% in corresponding month of last year i.e. February 2024.
10. Measured by 20% **weighted trimmed mean Rural** decreased to 5.2% on (YoY) basis in February 2025 as compared 5.4% in the previous month and 21.3% in February 2024. On (MoM) basis, it increased by 0.1% in February 2025 as compared an increase of 0.7% in the previous month and an increase of 0.4% in corresponding month of last year i.e. February 2024.

Figure 1: Urban Inflation - YoY, Special Indices

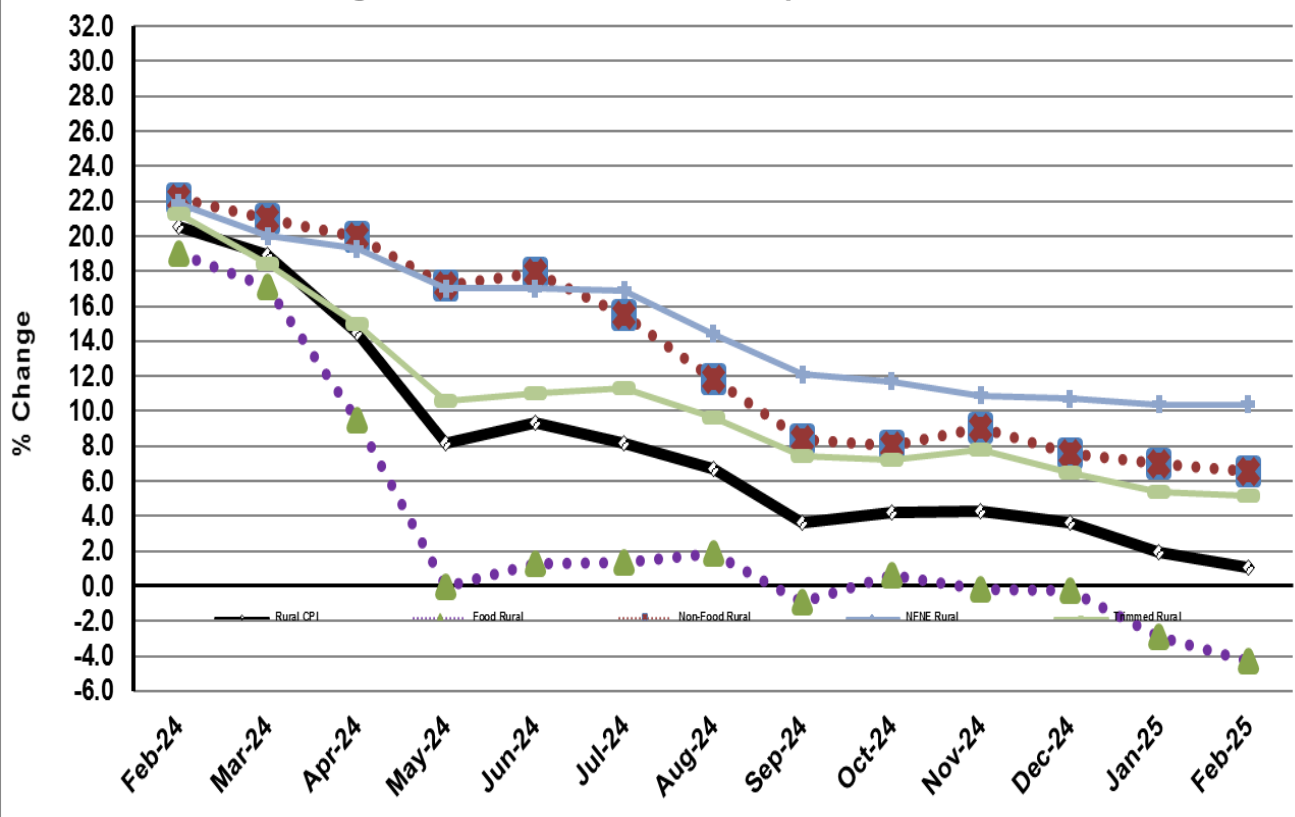


Figure 3: Urban Inflation - MoM, Special Indices

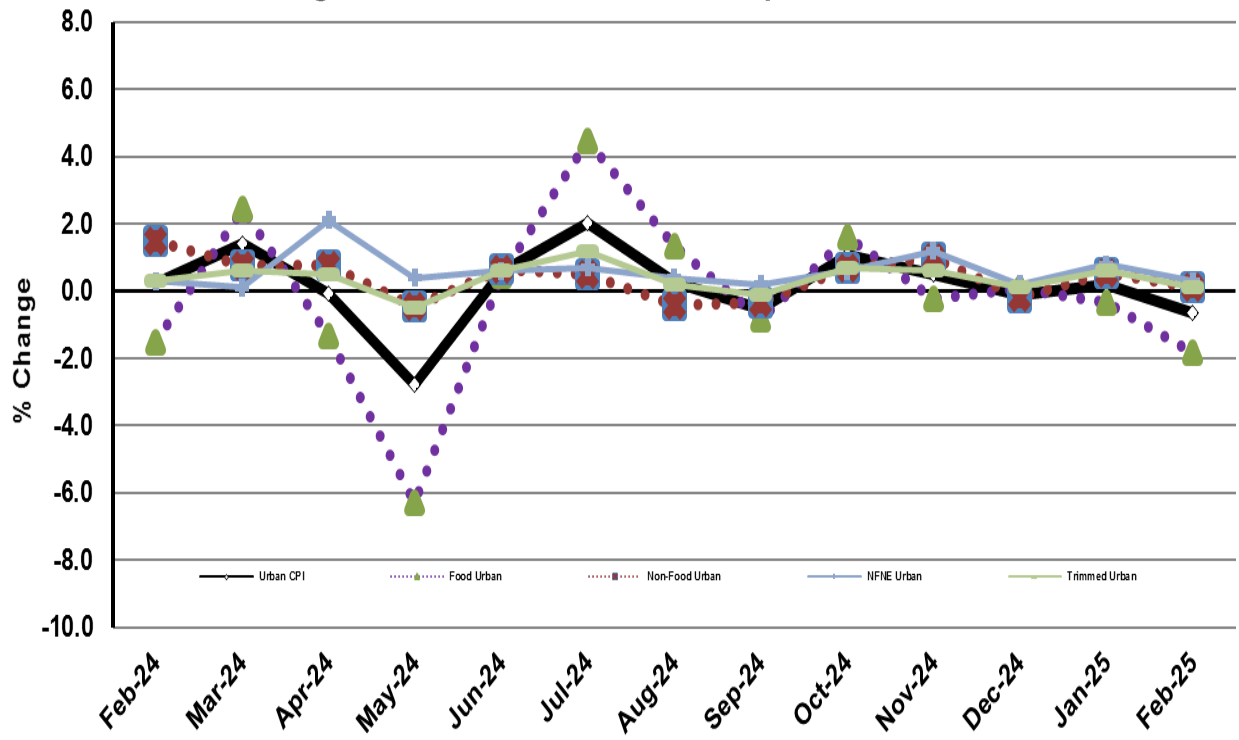


Figure 4: Rural Inflation - MoM, Special Indices

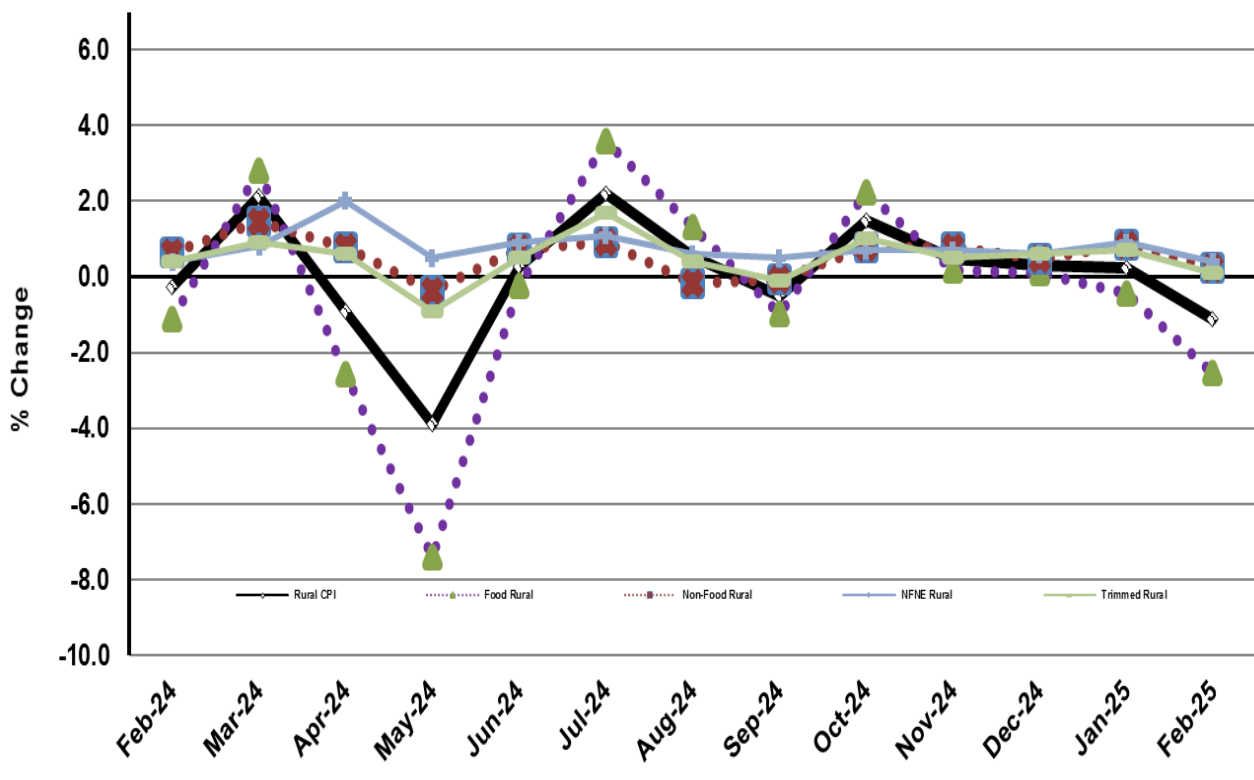


Figure 5: CPI YoY (National, Urban, Rural)

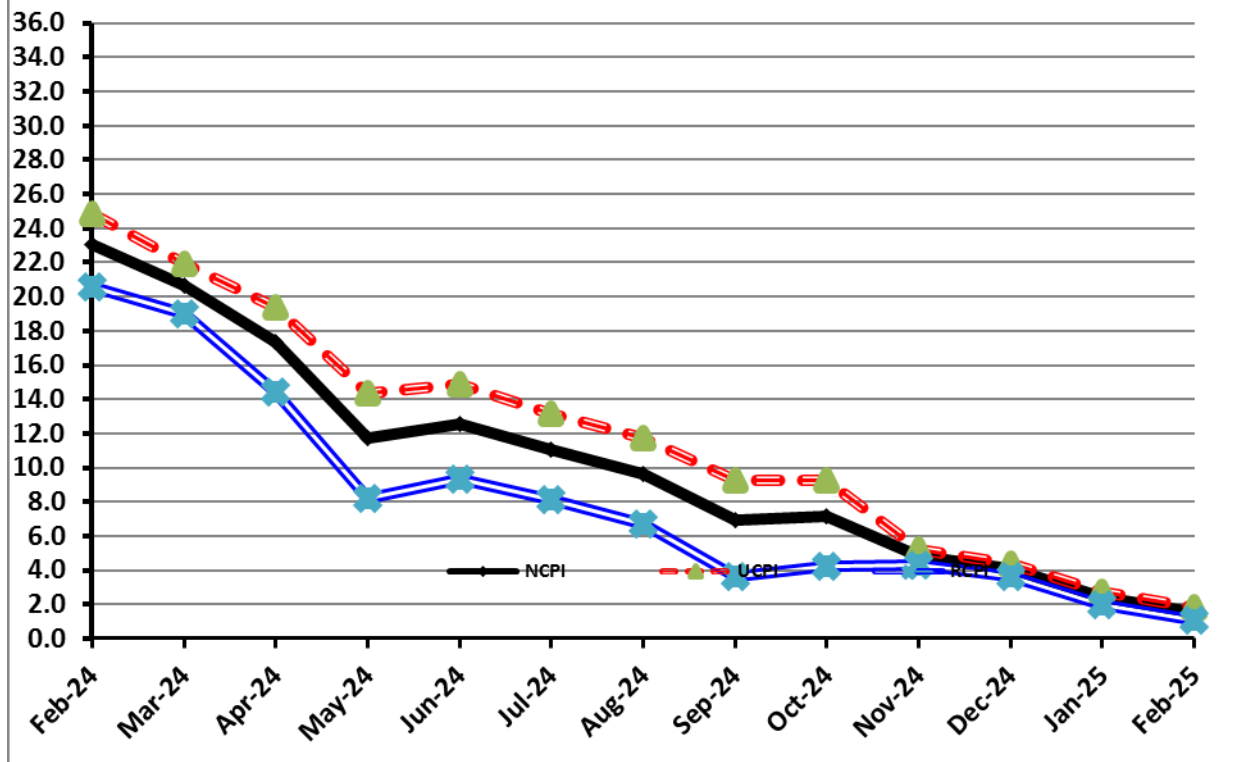
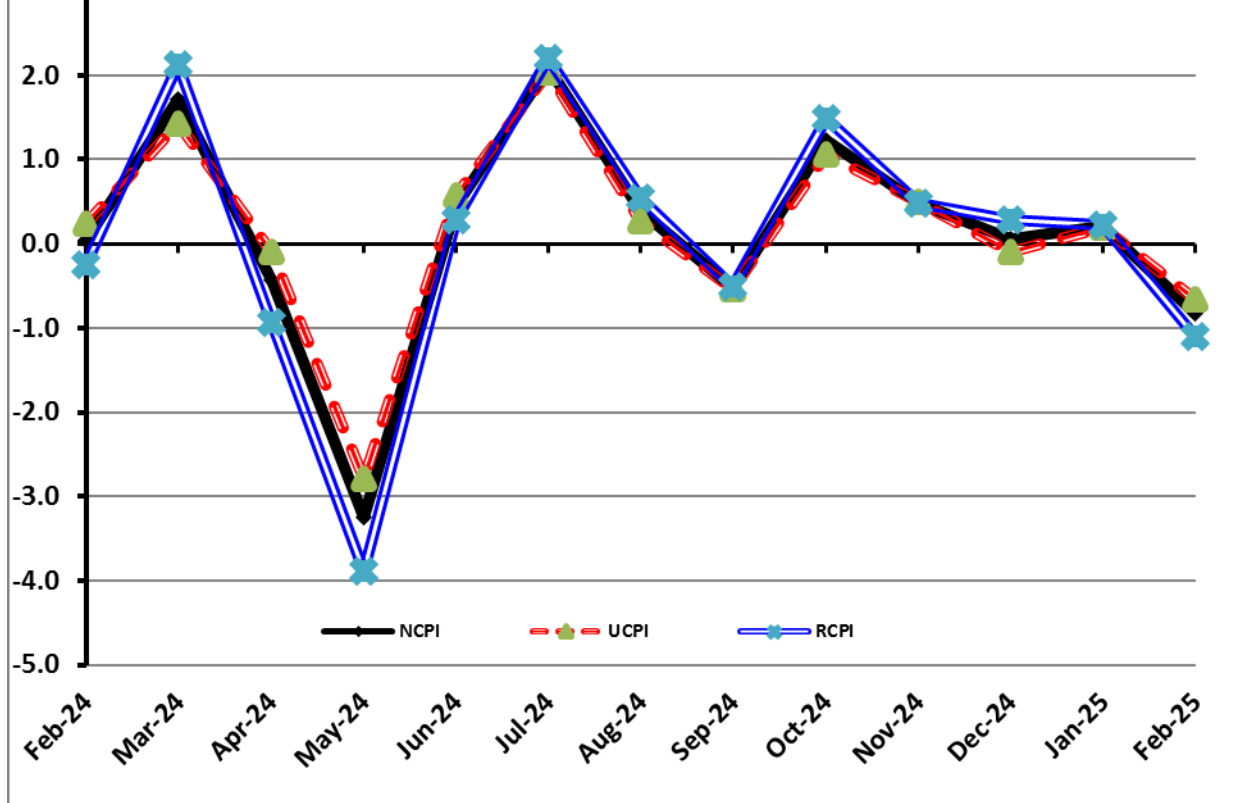


Figure 6: CPI MoM (National, Urban, Rural)

The **National Consumer Price Index** for **February 2025** is decreased by **0.83%** over **January 2025** and increased to **1.52%** over corresponding month of the last year i.e. **February 2024**.

The Urban Consumer Price Index for **February 2025** is decreased by **0.65%** over **January 2025** and increased to **1.81%** over corresponding month of the last year i.e. **February 2024**.

Increased: Fresh Fruits (14.99%), Sugar (9.35%), Butter (5.61%), Condiments and Spices (1.59%), Bakery and Confectionary (1.19%), Beverages (1.16%), Honey (1.12%), Vegetable Ghee (0.66%), Meat (0.46%), Rice (0.39%), Cooking Oil (0.35%), Readymade Food (0.33%), Beans (0.21%) and Milk Powder (0.03%).

Decreased: Tomatoes (56.76%), Onions (31.49%), Potatoes (20.10%), Fresh Vegetables (16.73%), Eggs (14.23%), Pulse Gram (10.21%), Tea (10.03%), Besan (8.68%), Gram Whole (5.46%), Wheat (2.97%), Pulse Mash (2.82%), Wheat Flour (2.23%), Chicken (1.51%), Pulse Masoor (1.49%), Pulse Moong (1.33%), Wheat Products (1.25%), Mustard Oil (1.19%), Fish (0.12%) and Milk Products (0.10%).

NON-FOOD:

Increased: Accommodation Services (5.07%), Major Tools & Equipments (1.16%), Mechanical Services (0.89%), Doctor (Mbbs) Clinic Fee (0.80%), Motor Fuel (0.75%), Construction Wage Rates (0.74%), Plastic Products (0.63%), Dental Services (0.51%) and Furniture & Furnishing (0.48%).

Decreased: Liquified Hydrocarbons (8.32%), Solid Fuel (1.48%), Transport Services (0.97%), Construcion Input Items (0.49%), Electricity Charges (0.28%) and Stationery (0.21%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. February, 2024 are given below:

FOOD

Increased: Pulse Moong (32.65%), Besan (28.97%), Pulse Gram (25.40%), Potatoes (22.88%), Fresh Fruits (21.55%), Butter (21.12%), Honey (20.77%), Milk Powder (20.58%), Meat (18.59%), Vegetable Ghee (16.61%), Fish (15.93%), Gram Whole (13.10%), Beans (11.63%), Mustard Oil (11.27%), Milk Fresh (11.14%), Milk Products (8.62%), Cooking Oil (8.06%), Sugar (7.21%) and Beverages (6.84%).

Decreased: Onions (56.59%), Tomatoes (48.42%), Wheat (36.13%), Wheat Flour (34.70%), Fresh Vegetables (27.04%), Pulse Mash (12.19%), Wheat Products (12.12%), Pulse Masoor (11.22%), Tea (10.20%), Eggs (9.36%), Rice (5.19%), Bakery & Confectionary (0.28%) and Chicken (0.14%).

NON-FOOD:

Increased: Motor Vehicle Tax (168.79%), Footwears (31.9%), Dental Services (26.55%), Drugs & Medicines (16.53%) and Medical Tests (15.48%).

Decreased: Electricity Charges (16.58%), Motor Fuel (5.09%), Liquified Hydrocarbons (2.76%) and Communication Apparatus (1.19%).

III. Rural Consumer Price Index (RCPI)

The Rural Consumer Price Index for February 2025 is decreased by 1.10% over January 2025 and increased to 1.09% over corresponding month of the last year i.e. February 2024.

Decreased: Tomatoes (55.57%), Onions (28.14%), Potatoes (26.59%), Fresh Vegetables (19.74%), Eggs (19.65%), Pulse Gram (8.81%), Besan (5.42%), Tea (4.87%), Gram Whole (4.48%), Pulse Mash (4.30%), Chicken (3.25%), Wheat Flour (2.30%), Pulse Masoor (2.22%), Wheat (1.50%) and Cooking Oil (1.08%).

NON-FOOD

Increased: Cleaning and Laundering (2.88%), Recreation and Culture (1.46%), Major Tools & Equipments (0.99%) and Dental Services (0.95%).

Decreased: Liquified Hydrocarbons (5.82%), Construction Input Items (1.31%) and Electricity Charges (0.28%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. February, 2024 are given below:

Increased: Besan (33.86%), Pulse Moong (32.16%), Pulse Gram (30.68%), Milk Powder (26.42%), Meat (21.01%), Honey (20.5%), Potatoes (20.27%), Fresh Fruits (19.83%), Butter (18.22%), Vegetable Ghee (16.98%), Fish (14.94%), Cooking Oil (14.44%), Dry Fruits (12.13%), Gram Whole (11.01%), Mustard Oil (10.63%), Milk Fresh (10.03%), Beans (9.34%), Readymade Food (9.05%), Milk Products (7.84%), Cigarettes (6.87%), Sugar (6.84%), Beverages (6.42%).

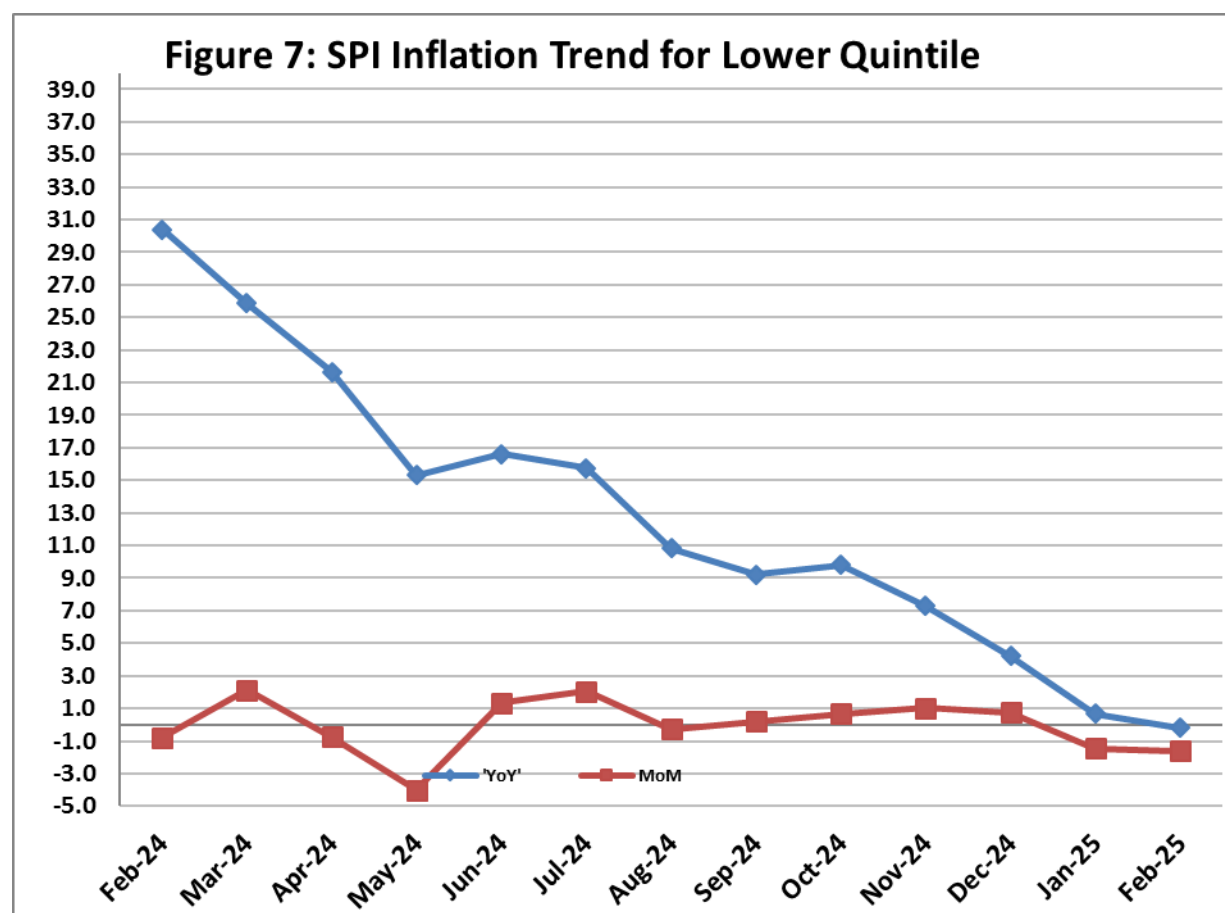
Decreased: Electricity Charges (16.58%), Motor Fuels (5.65%) and Liquified Hydrocarbons (3.33%).

IV. Sensitive Price Indicator

Quintile-wise percentage changes YoY and MoM are given below in Table 4. The series from February 2024 to February 2025 is also graphed below in Figure 7.

V. Wholesale Price Index

The Wholesale Price Index for **February, 2025** is decreased by **0.18%** over **January 2025**. It decreased by **0.66%** over the corresponding month of the last year i.e. **February, 2024**. YoY and MoM movements, from February, 2024 to February, 2025 are also graphed below in Figure 8.

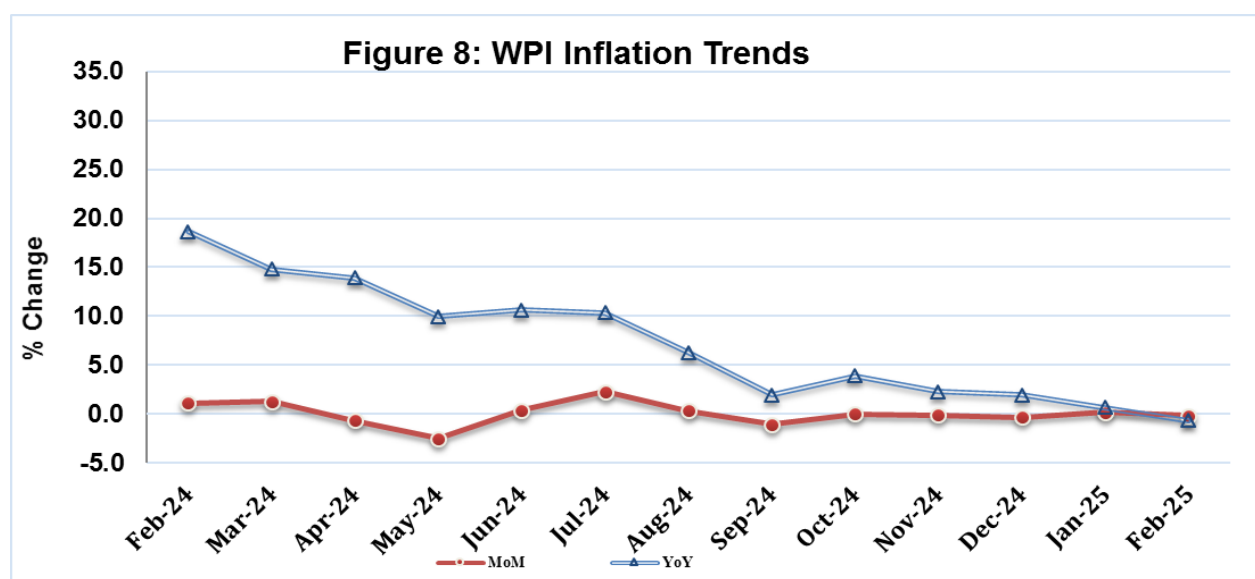
