

Inflation in Brief

- 1. CPI inflation General**, increased by 7.2% on year-on-year basis in October 2024 as compared to 6.9% in the previous month and 26.8% in October 2023. On month-on-month basis, it increased by 1.2% in October 2024 as compared to a decrease of 0.5% in the previous month and an increase of 1.0% in October 2023.
- 2. CPI inflation Urban**, remained stable at 9.3% on year-on-year basis in October 2024 as compared to the previous month and increase of 25.5% in October 2023. On month-on-month basis, it increased by 1.1% in October 2024 as compared to a decrease of 0.5% in the previous month and an increase of 1.1% in October 2023.
- 3. CPI inflation Rural**, increased by 4.2% on year-on-year basis in October 2024 as compared to 3.6% in the previous month and 28.7% in October 2023. On month-on-month basis, it increased by 1.5% in October 2024 as compared to a decrease of 0.5% in the previous month and an increase of 0.9% in October 2023.
- 4. SPI inflation** on YoY increased by 9.7% in October 2024 as compared to 9.2% a month earlier and 34.2% in October 2023. On MoM basis, it increased by 0.6% in October 2024 as compared to a increase of 0.2% a month earlier and an increase of 0.2% in October 2023.
- 5. WPI inflation** on YoY basis increased by 3.9% in October 2024 as compared to 1.9% a month earlier and an increase of 24.6% in October 2023. On MoM basis, it shows no change in October 2024 as compared to a decrease of 1.1% in the previous month and a decrease of 1.9% in corresponding month of last year i.e. October 2023.




Figure 2: Rural Inflation - YoY, Special Indices

- 6. Figures 1 and 2 show graphically the yearly data of Table 1.a for Urban and Rural CPI while Table 1.1 shows “Period Average” and “YoY” percentage changes in indices of three years.**

Core inflation (NFNE)

7. Measured by **non-food non-energy Urban** decreased to 8.6% on (YoY) basis in October 2024 as compared to 9.3% in the previous month and 18.5% in October 2023. On (MoM) basis, it increased by 0.6% in October 2024 as compared to an increase of 0.2% in previous month and an increase of 1.2% in corresponding month of last year i.e. October, 2023.
8. Measured by **non-food non-energy Rural** increased to 11.7% on (YoY) basis in October 2024 as compared to 12.1% in the previous month and 26.7% in October 2023. On (MoM) basis, it increased by 0.7% in October 2024 as compared to an increase of 0.5% in previous month and an increase of 1.0% in corresponding month of last year i.e. October 2023.

Core inflation (Trimmed)

9. Measured by 20% **weighted trimmed mean Urban** decreased to 6.4% on (YoY) basis in October 2024 as compared to 7.1% in the previous month and 24.6% in October 2023. On (MoM) basis, it increased by 0.7% in October 2024 as compared to a decrease of 0.1% in the previous month and an increase of 0.6% in corresponding month of last year i.e. October 2023.
10. Measured by 20% **weighted trimmed mean Rural** decreased to 7.2% on (YoY) basis in October 2024 as compared to 7.4% in the previous month and 30.4% in October 2023. On (MoM) basis, it increased by 1.0% in October 2024 as compared to a decrease of 0.1% in the previous month and an increase of 0.7% in corresponding month of last year i.e. October 2023.

Figure 1: Urban Inflation - YoY, Special Indices




Figure 3: Urban Inflation - MoM, Special Indices




Figure 4: Rural Inflation - MoM, Special Indices




Figure 5: CPI YoY (National, Urban, Rural)





Figure 6: CPI MoM (National, Urban, Rural)

Increased: Water Supply (8.65%), Electricity Charges (5.02%), Household Textiles (3.91%), Household Equipments (2.59%), Mechanical Services (2.06%), Furniture and Furnishing (2.01%), Postal Services (1.72%) and Hospitals Services (1.58%).

Decreased: Motor Fuel (2.31%), Transport Services (2.10%), Liquified Hydrocarbons (0.91%), Construcion Input Items (0.38%) and Washing Soap/Detergents/Match Box (0.37%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. October, 2023 are given below:

Decreased: Motor Fuel (15.60%), Liquified Hydrocarbons (4.90%), Electricity Charges (0.55%) and Communication Apparatus (0.46%).

III. Rural Consumer Price Index (RCPI)

The Rural Consumer Price Index for October 2024 is increased by 1.49% over September 2024 and increased to 4.23% over corresponding month of the last year i.e. October 2023.

Decreased: Sugar (4.16%), Pulse Mash (2.52%), Gur (1.70%), Pulse Masoor (1.65%), Potatoes (0.89%), Eggs (0.48%), Bakery and Confectionary (0.41%) and Wheat Products (0.20%).

NON-FOOD

Increased: Dental Services (6.09%), Electricity Charges (5.02%), Personal Effects (4.09%), Hospitals Services (1.51%), Recreation and Culture (1.43%), Water Supply (1.34%), Tailoring (1.26%), Readymade Garments (1.05%) and House Rent (1.02%).

Decreased: Motor Fuels (2.51%), Washing Soaps, Detergents and Match Box (0.41%), Transport Services (0.11%) and Construction Input Items (0.03%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. October, 2023 are given below:

Increased: Pulse Gram (63.11%), Onions (53.76%), Besan (48.25%), Chicken (26.39%), Pulse Moong (26.24%), Milk Powder (26.06%), Fish (24.25%), Meat (22.48%), Butter (21.49%), Beans (18.41%), Fresh Vegetables (16.69%), Gram Whole (16.39%), Dry Fruits (14.17%), Fresh Fruits (13.40%), Milk Products (11.34%), Milk Fresh (10.61%), Tomatoes (9.79%), Honey (9.05%), Readymade Food (8.16%) and Beverages (6.03%).

Decreased: Wheat Flour (34.58%), Wheat (34.50%), Sugar (10.69%), Wheat Products (9.70%), Rice (3.91%), Cooking Oil (2.17%), Gur (1.35%), Eggs (0.59%) and Vegetable Ghee (0.26%).

NON-FOOD

Increased: Motor Vehicle Tax (126.61%), Woolen Readymade Garments (36.50%), Education (22.96%), Communication Services (18.70%), Cotton Cloth (18.65%), Marriage Hall Charges (16.39%), Dental Services (14.85%), Woolen Cloth (14.64%), Furniture & Furnishing (13.67%) and Construction Input Items (13.57%).

Quintile-wise percentage changes YoY and MoM are given below in Table 4. The series from October 2023 to October 2024 is also graphed below in Figure 7.



V. Wholesale Price Index


