## **TRADE SUMMARY**

April-June, 2024

### **EXPORTS**

The total exports of Pakistan during Apr-Jun, 2024 amounted to Rs. 2,156,179.12 million showing a decrease of 2.84% over Jan-Mar, 2024 and increased by 12.85% over Apr-Jun, 2023. In terms of US dollar, the export during Apr-Jun, 2024 amounted to \$ 7,748.25 million showing a decrease of 2.44% over Jan-Mar, 2024 and showing an increase of 15.86% over Apr-Jun, 2023.

Export during Jul-Jun, 2024 totaled Rs. 8,674,104.28 million showing an increase of 26.46% over the corresponding period of last year. While in terms of US dollars, exports stand at \$ 30,674.63 million showing an increase of 10.64% over the corresponding period of last year.

### **IMPORTS**

The total imports of Pakistan during Apr-Jun, 2024 amounted to Rs. 4,097,704.08 million showing an increase of 5.38% over Jan-Mar, 2024 and increased by 24.98% over Apr-Jun, 2023. In terms of US dollar, the imports during Apr-Jun, 2024 amounted to \$ 14,725.20 million showing an increase of 5.81% over Jan-Mar, 2024 and increased by 28.34% over Apr-Jun, 2023.

Import during Jul-Jun, 2024 totaled Rs. 15,482,119.69 million showing an increase of 14.91% over the corresponding period of last year. In terms of US dollars, Imports stand at stands at \$ 54,79.08 million showing a decrease of 0.76% over the corresponding period of last year.

### **TOTAL TRADE**

The total trade of Pakistan during Apr-Jun, 2024 amounted to Rs. 6,253,883.20 million showing an increase of 2.40% over Jan-Mar, 2024 and increased by 20.51% over Apr-Jun, 2023. In terms of US dollar, the total trade during Apr-Jun, 2024 amounted to \$ 22,473.45 million showing an increase of 2.81% over Jan-Mar, 2024 and increased by 23.74% over Apr-Jun, 2023.

Total trade during Jul-Jun, 2024 totaled Rs. 24,156,223.97 million showing an increase of 18.81% over the corresponding period of last year. In terms of US dollars, total trade stands at \$ 85,453.71 million showing an increase of 3.05%.

### **BALANCE OF TRADE**

Balance of trade in Apr-Jun, 2024 was unfavorable to Pakistan to the tune of Rs. 1,941,524.96 million equivalents to US \$6,976.96 million, whereas during the period of Jul-Jun, 2024 it was unfavorable to the tune of Rs. 6,808,015.41 million rupees equivalent to US \$ 24,104.45 million.

## **CHAPTER-I**

### **I- EXPORT BY GROUP/COMMODITIES**

#### **Food Group**

During Apr-Jun, 2024 export of goods belonging to Food Group decreased by 24.96% over Jan-Mar, 2024 and increased by 51.77% over Apr-Jun, 2023. Food Group contributed 16.81% of total exports.

The export of food group during Jul-Jun, 2024 increased by 76.63% compared to the same period of last year. This Group contributed 16.93% of total export during Jul-Jun, 2024.

#### **Textile Group**

During Apr-Jun, 2024 export of Textile goods increased by 1.09% over Jan-Mar, 2024 and increased by 2.01% over Apr-Jun, 2023. Textile Group contributed 52.00% of total exports.

The export of textile group increased by 15.87% for the period of Jul-Jun, 2024 compared to the same period of last year. Textile Group contributed 51.88% of total exports during Jul-Jun, 2024.

#### **Manufactures Group**

During Apr-Jun, 2024 export of manufactured goods increased by 17.66% over Jan-Mar, 2024 and increased by 31.43% over Apr-Jun, 2023. Manufactures Group contributed 7.82% of total exports.

Export for manufacture group during Jul-Jun, 2024 increased by 26.70% compared to the same period of last year. Manufacture Group contributed 6.84% of total exports during Jul-Jun, 2024.

## **II- DIRECTION OF EXPORTS**

During Apr-Jun, 2024 country-wise U. S. A. was at the top of the export list followed by United Kingdom, China, Germany, United Arab Emirates, Netherlands, Spain, Afghanistan, Italy & Belgium. The share of these ten countries in total exports for Apr-Jun, 2024 was 62.06% as against 66.27% in Apr-Jun, 2023.

During Jul-Jun, 2024 Country-wise, U.S.A. was at the top of the exports list followed by China, United Kingdom, United Arab Emirates, Germany, Netherlands, Spain, Afghanistan, Italy and Bangladesh. The share of these ten countries in total exports for Jul-Jun, 2024 was 61.62% as against 65.34% in the same period of last year.

### **III- EXPORT BY ECONOMIC CATEGORIES**

Export of Primary Commodities during Apr-Jun, 2024 increased by 51.30%, Semi- Manufactures decreased by 23.17% and Manufactured Goods increased by 8.82% over Apr-Jun, 2023. Whereas, their share in total export stands at 20.45%, 5.22% and 74.33% respectively for Apr-Jun, 2024.

Exports of Primary Commodities during Jul-Jun, 2024 increased by 73.39%, Semi-Manufactures increased by 20.45% and Manufactured Goods increased by 17.29%. Whereas, their respective share in total export for the period of Jul-Jun, 2024 stood at 21.90%, 6.29% and 71.81%.

## CHAPTER-II

### I – IMPORTS BY GROUPS/COMMODITIES

#### **Food Group**

During Apr-Jun, 2024 import of goods belonging to Food Group decreased by 5.65% over Jan-Mar, 2024 and decreased by 11.83% over Apr-Jun, 2023. This group contributed 6.93% of total imports.

The import of food group during Jul-Jun, 2024 decreased by 8.12% compared to the same period of last year. This group contributed 8.10% of total imports during Jul-Jun, 2024.

#### **Machinery & Transport Group**

During Apr-Jun, 2024 import of goods belonging to Machinery & Transport group increased by 22.13% over Jan-Mar, 2024 and increased by 105.42% over Apr-Jun, 2023. This group contributed 21.99% of total imports.

The import of goods belonging to Machinery & Transport group during Jul-Jun, 2024 increased by 58.83% compared to the same period of last year. This group contributed 18.77% of total import during Jul-Jun, 2024.

#### **Petroleum Group**

During Apr-Jun, 2024 import of goods belonging to Petroleum group increased by 22.75% over Jan-Mar, 2024 and increased by 21.03% over Apr-Jun, 2023. This group contributed 24.30% of total imports.

The import of petroleum group during Jul-Jun, 2024 increased by 11.67% compared to the same period of last year. This group contributed 22.24% of total imports during Jul-Jun, 2024.

#### **Textile Group**

During Apr-Jun, 2024 import of goods belonging to textile group increased by 7.44% over Jan-Mar, 2024 and increased by 7.04% over Apr-Jun, 2023. This group contributed 1.94% of total imports.

The import of Textile group during Jul-Jun, 2024 increased by 18.69% compared to the same period of last year. This group contributed 2.00% of total imports during Jul-Jun, 2024.

## **Chemical Group**

During Apr-Jun, 2024 import of goods belonging to Chemical group slightly increased by 0.08% over Jan-Mar, 2024 and increased by 7.75% over Apr-Jun, 2023. This group contributed 14.52% of total imports.

The import of chemical group during Jul-Jun, 2024 increased by 10.34% compared to the same period of last year. This group contributed 15.52% of total imports during Jul-Jun, 2024.

## **Metal Group**

During Apr-Jun, 2024 import of Metal products increased by 6.98% over Jan-Mar, 2024 and increased by 46.46% over Apr-Jun, 2023. This group contributed 5.89% of total imports.

The import of metal group during Jul-Jun, 2024 increased by 25.25% compared to the same period of last year. This group contributed 5.98% of total imports during Jul-Jun, 2024.

## **Miscellaneous Group**

During Apr-Jun, 2024 imports of miscellaneous commodities decreased by 4.07% over Jan-Mar, 2024 and increased by 27.64% over Apr-Jun, 2024. This group contributed 0.86% of total imports.

The import of miscellaneous group during Jul-Jun, 2024 increased by 14.89% compared to the same period of last year. This group contributed 0.93% of total imports during Jul-Jun, 2024.

### II- DIRECTION OF IMPORTS

During Apr-Jun, 2024 Country-wise China was at the top of the import list followed by United Arab Emirates, Saudi Arabia, Qatar, Indonesia, Kuwait, Oman, U.S.A., Singapore & Japan. The share of these ten countries in total imports for Apr-Jun, 2024 was 75.27% as against 70.48% in Apr-Jun, 2023.

During Jul-Jun, 2024 Country-wise China was on the top of the import list followed by United Arab Emirates, Saudi Arabia, Qatar, Indonesia, Kuwait, U.S.A, Singapore, Japan and Iran (Islamic R.). The combined share of these ten countries in total imports during this period was 70.49% as against their combined share of 67.29% during the corresponding period of last year.

### III- IMPORTS BY BROAD ECONOMIC CATEGORIES

Imports of Consumer Goods/Intermediate Goods during Apr-Jun, 2024 decreased by 9.76%, Consumer Goods increased by 85.99%, Consumer Goods/Capital Goods increased by 27.94%, Intermediate Goods increased by 21.97%, Intermediate Goods/Capital Goods increased by 22.45%, Intermediate Goods/Consumer Goods increased by 18.64%, Capital Goods increased by 43.70%, Capital Goods/Consumer Goods increased by 18.13% and Capital Goods/Intermediate Goods increased by 79.72% over Apr-Jun, 2023. Their respective share in total imports were 22.72%, 10.57%, 0.13%, 56.72%, 0.08%, 2.42%, 6.75%, 0.59% and 0.04% respectively for Apr-Jun, 2024.

Imports of Consumer Goods/Intermediate Goods during Jul-Jun, 2024 decreased by 5.10%, Consumer Goods increased by 56.40%, Consumer Goods/Capital Goods increased by 29.56%, Intermediate Goods decreased by 13.73%, Intermediate Goods/Capital Goods increased by 39.48%, Intermediate Goods/Consumer Goods increased by 18.31%, Capital Goods decreased by 5.59%, Capital Goods/Consumer Goods increased by 54.17% and Capital Goods/Intermediate Goods increased by 39.20% over Jul-Jun, 2023. Their respective share in total imports were 21.37%, 10.74%, 0.16%, 58.53%, 0.06%, 2.47%, 5.94%, 0.68% and 0.04% respectively for FY2024.
