Review of Foreign Trade April, 2011

EXPORTS

The total Exports of Pakistan during April, 2011 amounted to Rs 200,164.25 million as against Rs. 210,207.73 million in March, 2011 and Rs. 142,760.03 million during April, 2010 showing a decrease of 4.78% over March, 2011 while higher by 40.21% April, 2010.

Exports during July – April, 2011 totalled Rs. 1,717,379.89million as against Rs. 1,319,176.27 million during the corresponding period of last year showing an increase of 30.19 percent.

In terms of U.S dollars, the exports during April, 2011 amounted to \$ 2,365.23 million as against \$ 2,463.24 million in March, 2011 and \$ 1,700.77 million during April, 2010 showing a decrease of 3.98% over March, 2011 while higher by 39.07% over April, 2010.

In terms of U.S. dollars, the exports during Exports during July –April, 2011 totalled \$ 20,091.88million as against \$ 15,773.15 million during the corresponding period of last year showing an increase of 27.38 percent.

IMPORTS

The total Imports of Pakistan during April, 2011 amounted to Rs. 274,756.51million as against Rs. 291,580.82million in March, 2011 and Rs. 253,131.31 million during April, 2010 showing a decrease of 5.77% over March, 2011 while higher by 8.54% over April, 2010.

Imports during July – April, 2011 amounted to Rs. 2,758,525.99million as against Rs. 2,352,363.35 million during the corresponding period of last year showing an increase of 17.27 percent.

In terms of US dollars, the imports during April, 2011 amounted to \$ 3,246.65million as against \$ 3,416.78 million in March, 2011 and \$ 3,015.67 million during showing a decrease of 4.98% over March, 2011 while higher by 7.66% over April, 2011.

In term of U.S. dollars, the imports during July – April, 2011 amounted \$ 32,262.92 million as against \$ 28,122.41million during the corresponding period of last year showing an increase of 14.72 percent.

Based on the above figures of exports & imports the balance of trade in April, 2011 was unfavourable for Pakistan to the tune of 74,592.26 million rupees equal to US \$ 881.42 million and the balance of trade during July – April, 2011 was also unfavourable to the tune of 1,041,146.10 million rupees equal to U.S. \$ 12,171.04 million.

I - Exports by Group/Commodities

The total Exports of Pakistan during April, 2011 amounted to Rs 200,164.25 million as against Rs. 210,207.73 million in March, 2011 and Rs. 142,760.03 million during April, 2010 showing a decrease of 4.78% over March, 2011 while higher by 40.21% April, 2010.

Exports during July – April, 2011 totalled Rs. 1,717,379.89million as against Rs. 1,319,176.27 million during the corresponding period of last year showing an increase of 30.19 percent.

Comparative figure of exports by group/commodities during April, 2011 compared to March, 2011 and April, 2010 are given in table-1 and cumulative exports for the period July – April, 2011 of current financial year compared to the corresponding period of last year are given in table-2.

Primary Commodities

During April, 2011 the 6 selected commodities of Primary Commodities contributed 15.16% of total exports in which the share of Rice was (8.28%), Fruit, vegetables & preparation thereof (3.10%) and Raw cotton (excl.linters) (2.14%).

During July – April, 2011 these 6 commodities contributed 14.27% of total exports showing a decrease of 11.15% as against their combined share of 16.06% during the corresponding period of last year.

Textile Manufactures

During April, 2011 the 9 selected commodities of Textile Manufactures contributed 50.17% of total exports in which the share of Cotton fabrics was (10.38%), Knitwear (8.11%), Bed-wear (7.76%), Cotton yarn (7.70%) and Articles of apparel & clothing accessories (excl. knitwear) (7.12%).

During July – April, 2011 these 9 commodities contributed 52.68% of total exports showing an increase of 3.95% as against their combined share of 50.68% during the corresponding period of last year.

Other Manufactures

During April, 2011 the 7 selected commodities of other Manufactures contributed 13.28% of total exports in which the share of Petroleum products was (6.39%), Leather (1.97%), Leather clothes & accessories (1.58%), Sports goods (excl. toys) (1.33%) and Surgical instruments (1.09%).

During July – April, 2011 these 7 commodities contributed 13.13% of total exports showing an increase of 0.98% as against their combined share of 13.26% during the corresponding period of last year.



II – Analysis of Selected Commodities of Exports

Cotton Fabrics

Cotton fabrics maintained its first position in its group during April, 2011 as in the previous month. During this month its exports amounted to Rs. 20,772.23 million as against Rs. 24,124.80million in March, 2011 and Rs. 13,118.88 million during April, 2010 showing a decrease of 13.90% over March, 2011 while higher by 58.34% over April, 2010.

During July – April, 2011 of current financial year 1,890,047 thousand sq. meters of cotton fabrics valued at Rs. 177,894.50million were exported as against 1,489,311 thousand sq. meters valued at Rs. 124,305.41million during the same period of last year showing an increase of 26.91% in terms of quantity and by 43.11% in terms of value. During July – April, 2011 the average unit price of cotton fabrics increased to Rs.94.12 per sq. meter from Rs. 83.47 per sq. meter during the corresponding period of last year showing an increase of 12.76 percent. Main buyers of cotton fabrics during July – April, 2011 of current financial year were Turkey (Rs. 26,262.75million), Bangladesh (Rs. 19,590.26 million), Italy (Rs. 13,764.33million), Cambodia (Rs. 10,440.07 million), Germany (Rs. 8,514.71million), Sri Lanka (Rs. 7,515.34million), U.S.A. (Rs. 7,366.69million), Spain (Rs. 6,706.21million), Belgium (Rs. 5,035.08million) and South Africa (Rs. 4,520.30million). Their total take-off accounted for 61.67% of total exports of cotton cloth as compared to their combined share of 59.36% during the same period of last year.

Variety-wise exports of cotton fabrics during July – April, 2011 of current financial year and the corresponding period of last year are given below.

Cotton Yarn

Cotton yarn came down to fourth position in its group during April, 2011 from its Second position in the previous month. Its exports in this month amounted to Rs. 15,413.84million as against Rs 21,016.26 million in March, 2010 and Rs. 11,541.55million in April, 2010 showing a decrease of 26.66% over March, 2011 while higher by 33.55% over April, 2010.

During July – April, 2011 exports of cotton yarn amounted to Rs. 160,717.76million as against Rs. 103,496.63million in the corresponding period of last year depicting a rise of 55.29 percent. In terms of quantity 463,283 thousand Kg. of cotton yarn was exported during July – April, 2011 of current financial year as against 562,241 thousand Kg. during the corresponding period of last year showing a decrease of 17.60 percent. The average unit price of cotton yarn for the period July – April, 2011 of current financial year was Rs. 346.91per Kg. as against Rs. 184.08 per Kg. in the same period of last year showing an increase of 88.46 percent.

China (Rs. 67,570.66million), Hong Kong (Rs. 21,994.00million), Bangladesh (Rs. 14,505.06million), Korea Rep. of (Rs. 10,205.24million), Portugal (Rs. 5,749.52million), Turkey (Rs. 4,853.86million) Japan (Rs. 4,600.87million) and Italy (Rs. 3,990.27million) were major buyers of cotton yarn during this period. Their combined share accounted for 83.05%of total exports of cotton yarn as compared to their combined share of 84.59%during the same period of last year.

Variety-wise exports of cotton yarn in terms of quantity and value during July–April, 2011 of the current financial year and corresponding period of last year are given below:-

Rice

Rice maintained its first position in its group during April, 2011 as in the previous month. In this month it fetched to Rs. 16,575.61million as against Rs. 17598.46 million in March, 2011 and Rs. 15,882.54 million in April, 2010 showing a decrease of 5.81% over March, 2011 while higher by 4.36% over April, 2010.

During July – April, 2011 its exports amounted to Rs. 153,210.96million as against the exports of Rs. 151,841.96million during the corresponding period of last year showing an increase of 0.90 percent. U.A.E. was the leading buyer of rice during July – April, 2011 with its share of 15.01% in the total exports of this item. Other major buyers were Saudi Arabia (5.47%), Afghanistan (5.05%), Oman (5.04%), Bangladesh (4.78%), Iran (Islamic Rep.) (4.30%) and Kenya (3.97%). These seven countries accounted for 43.61% of total exports of rice during this period.

Exports of rice to major countries during July – April, 2011 and the corresponding period of last year are given below.

Unit price of rice basmati for April, 2011 was Rs. 73,465.94 per tonne as against Rs. 70,127.87 in April, 2010 showing a rise of 4.76 percent. Average unit price of this variety for July – April, 2011 of current financial year was Rs. 69,974.58 per tonne as against Rs. 70,109.78 for the same period of last year showing a fall of 0.19 percent.

Unit price of rice "Other Varieties" increased to Rs. 43,283.16 per tonne in April, 2011 from Rs. 34,374.87 in April, 2010 showing a rise of 25.92 percent. The average unit price of rice "Other Varieties" for July – April, 2011 at Rs. 40,628.33 per tonne was higher by 13.48% compared to average unit price of Rs. 35,803.08 per tonne for the same period of last year.

Petroleum Products

Petroleum products maintained its first position in its group during April, 2011 as in the previous month. In this month its exports amounted to Rs. 12,787.29million as against Rs. 9,890.25 million in March, 2011 and Rs. 7,977.69 million in April, 2010 showing an increase of 29.29% over March, 2011 by 60.29% over April, 2010.

Exports of this item during July – April, 2011 of current financial year stood at Rs. 97,560.00million as against exports of Rs. 68,821.17 million during the corresponding period of last year showing an increase of 41.76 percent.

In terms of quantity 1,432,546 tonnes of petroleum products were exported during July – April, 2011 of current financial year as against 1,207,264 tonnes exported during the corresponding period of last year showing an increase of 18.66 percent.

The main buyers of petroleum products during July – April, 2011 were Afghanistan (Rs. 60,946.75 million) and U.A.E. (Rs. 25,426.71 million). These two countries accounted for 88.53% of total exports of petroleum products during July – April, 2011 as against their combined share of 85.45% during the same period of last year.

Leather

Leather maintained its second position in its group during April, 2011 as in the previous month. Its exports in this month amounted to Rs. 3,942.02million as against Rs. 4,067.27 million in March, 2011 and Rs. 3,095.45 million in April, 2010 showing a decrease of 3.08% over March, 2011 while higher by 27.35% over April, 2010.

Exports of this item during July – April, 2011 totaled Rs. 31,693.46million as against Rs. 21,646.03million during the corresponding period of last year showing a rise of 46.42 percent. In terms of quantity 23,009,613 sq. meters of leather was exported during July – April, 2011 as against 18,358,687 sq. meters exported during the corresponding period of last year showing an increase of 25.33percent.

The main buyers of leather during July – April, 2011 were Hong Kong (Rs. 8,814.32million), Italy (Rs. 4,146.84million), China (Rs. 3,464.47million), Korea Rep. of (Rs. 2,995.52million), Turkey (Rs. 1,658.41million), Viet Nam (Rs. 949.79million), India (Rs. 932.22million) and Indonesia (Rs. 920.88million) whose combined share in total exports of leather was 75.35% as against their combined share of 73.49% during the same period of last year.

Carpets, Carpeting, Rugs & Mats

Carpets, carpeting, rugs and mats maintained its sixth position in its group during April, 2011 as in the previous month. Its exports in April, 2011 amounted to Rs. 1,106.00million as against Rs. 1,081.06 million in March, 2011 and Rs. 1,079.45 million in April, 2010 showing an increase of 2.31% over March, 2011 by 2.46% over April, 2010.

Exports of this item for July – April, 2011 of current financial year amounted to Rs. 9,476.26million as against Rs. 9,770.53 million during the corresponding period of last year showing a decrease of 3.01 percent.

In terms of quantity 2,177,398 sq. meters of carpets, carpeting, rugs & mats were exported during July – April, 2011 of current financial year as against 2,170,412 sq. meters exported during the corresponding period of last year showing an increase of 0.32 percent.

The average unit price of carpets of wool hand knotted was Rs. 5,058.30per sq. meter during July– April, 2011 as against Rs. 4,935.83 per sq. meter in the corresponding period of last year showing a rise of 2.48 percent. U.S.A. (Rs. 3,050.41million), Germany (Rs. 1,058.60million), Italy (Rs. 884.31million), Turkey (Rs. 805.70million), France (Rs. 442.23million), U.K. (Rs. 374.76million), Japan (Rs. 356.93million) and South Africa (Rs. 331.63million) were the main buyers of carpets, carpeting, rugs & mats during July – April, 2011. They together accounted for 77.10% during July – April, 2011 as compared to their combined share of 75.41% during the same period of last year.

Raw Cotton

Raw Cotton maintained its third position in its group during April, 2011 as in the previous month. Its exports in this month amounted to Rs. 4,284.43million as against Rs. 3,979.51 million in March, 2011 and Rs. 94.08 million in April, 2010 showing an increase of 7.66 % over March, 2011 by 4,454.03% over April, 2010.

Exports of this item during July – April, 2011 amounted to Rs. 27,960.96million as against Rs. 16,234.02million showing an increase of 72.24% compared to the same period of last year. In terms of quantity 131,329 tonnes of raw cotton was exported during July – April, 2011 as against 159,245 tonnes exported during the same period of last year showing a decrease of 17.53 percent. The average unit price of cotton American was Rs. 158,141.03per tonne during July – April, 2011 as against Rs. 112,951.07 per tonne during the same period of last year showing an increase of 40.01 percent. The main buyers of raw cotton during July – April, 2011 were Bangladesh (Rs. 9,884.22 million), China (Rs. 6,037.38 million), Viet Nam (Rs. 1,265.02million) and Thailand (Rs. 1,116.46million) .They together accounted for 76.02 % of total exports of raw cotton during July – April, 2011 as against their combined share of 76.30 % during the corresponding period of last year.

III - Direction of Exports

Exports by Territories/Regions and Major countries during April, 2011 compared with April, 2010 are given in table 3 & 4 and cumulative Exports by Territories/Regions and Major countries for the period July – April, 2011 of the current financial year compared with the same period of last year are given in table 5 & 6 respectively.

During the month of April, 2011, (24.83%) of total exports went to European Union as against 23.46% in April, 2010. The share of North America during April, 2011 was 16.10% as against 17.15% in April, 2010. The share of Middle East during April, 2011 was 19.14% as against 17.96 % in April, 2010. Country-wise, U.S.A. was at the top of the exports list for April, 2011 followed by Afghanistan, U.A.E., Germany, United Kingdom and Turkey .The share of these six countries in total exports for April, 2011 was 48.32 % as against their combined share of 43.43 % in April, 2010.

During July – April, 2011 the share of European Union in total Exports was 24.60% as against 23.89% in April, 2010. The share of North America decreased to 16.73% from 18.15 % during the same period of last year. The share of Middle East decreased to 17.65% from 19.19% during the same period of last year.

Country-wise, U.S.A. was at the top of the exports list for July –April, 2011 followed by Afghanistan, U.A.E., China, Germany and United Kingdom. The share of these six countries in total exports for July –April, 2011 of the current financial year was 49.03 % as against their combined share of 49.34 % in the same period of last year.

IV - Exports by Economic Categories

Performance of exports by economic categories during April, 2011 and July – April, 2011 of the current financial year compared to the same period of last year are shown in table-7.

During April, 2011 exports of primary commodities increased by 54.29%, semi-manufactures by 35.11% and manufactured goods by 37.59% during the current month as compared to the same month of last year.

During July – April, 2011 exports of primary commodities were higher by 26.85%, semi-manufactures by 59.94% and manufactured goods by 26.50% as compared to the same period of last year.

I – Imports by Group/Commodities

Imports into Pakistan during April, 2011 amounted to Rs. 274,756.51million as against the imports of Rs. 291,580.82 million in the previous month and Rs. 253,131.31 million during the corresponding month of last year showing a decrease of 5.77% over previous month but higher by 8.54% over the corresponding month of last year.

Imports during July – April, 2011 amounted to Rs. 2,758,525.99million as against Rs. 2,352,363.35 million during the corresponding period of last year showing an increase of 17.27 percent.

Comparative figures of imports by group/commodities during April, 2011, March, 2011 and April, 2010 are given in Table-8 and cumulative imports for July – April, 2011 of current financial year and the previous year are given in Table 9.

Food Group

During April, 2011 the 5 selected commodities of Food group contributed 9.28% of total imports in which the share of Palm oil and Pulses were 6.81% and 1.11% respectively.

During July – April, 2011 this group contributed 7.42% of total imports showing an increase of 35.40 % as against their combined share of 5.48% during the corresponding period of last year.

Machinery & Transport Group

During April, 2011 Machinery & Transport group contributed 22.19% of total imports in which the share of Machinery and Transport equipment were 14.72% and 7.47% respectively.

During July – April, 2011 this Group contributed 19.15% of the total imports showing a decrease of 12.32% as against their combined share of 21.84% during the corresponding period of last year.

Petroleum Group

During April, 2011 Petroleum group contributed 20.90% of total imports in which the share of Petroleum crude and Petroleum products were 13.77% and 7.13% respectively.

During July – April, 2011 this group contributed 27.18% of total imports showing a decrease of 5.49% as against their combined share of 28.76% during the corresponding period of last year.

Textile Group

During April, 2011 Textile group contributed 3.34% of total imports in which the share of Synthetic fibre and Synthetic & artificial silk yarn were 2.01% and 1.34% respectively.

During July – April, 2011 this group contributed 2.82% of total import showing an increase of 36.89% as against their combined share of 2.06% during the corresponding period of last year.

Chemical Group

During April, 2011 Chemical group contributed 18.38% of total imports in which the share of Chemical (excl. fertilizer, medicines & insecticide) were (15.04%), Medicinal product (2.00%), Fertilizer manufactured (0.86%) and Insecticide (0.49%).

During July – April, 2011 chemical group contributed 15.89% of the total imports showing a decrease of 5.86% as against their combined share of 16.88% during the corresponding period of last year.

Metal Group

During April, 2011 Metal group contributed 4.56% of total imports in which the share of Iron & steel and Iron & steel scrap were 3.33% and 1.23% respectively.

During July – April, 2011 this group contributed 4.39% of total imports showing a decrease of 11.85% as against their combined share of 4.98% during the corresponding period of last year.

Miscellaneous Group

During April, 2011 miscellaneous group contributed 1.78% of total imports in which the share of Paper & paper products and Tyres & tubes were 1.23% and 0.55% respectively.

During July – April, 2011 this group contributed 1.57% of total imports showing an increase of 35.34% as against their combined share of 1.16% during the corresponding period of last year.



II – Analysis of Selected Commodities of Imports

POL

Imports of POL during April, 2011 valued at Rs. 57,428.27million was lower by 25.58% compared to March, 2011 Rs. 77,165.75 million and by 8.04 % compared to April, 2010 Rs. 62,449.06 million. Cumulative imports of POL during the period July – April, 2011 amounted to Rs. 749,837.75million as against Rs. 676,493.39 million during the corresponding period of last year showing an increase of 10.84 percent.

The share of POL in total imports in April, 2011 was 20.90% as against 26.46% in March, 2011 and by 24.67% in April, 2010. During July – April, 2011 its share was 27.18% as against 28.76% in the corresponding period of last year.

Chemicals (Excluding fertilizer, insecticide & medicines)

Imports of chemicals (Excluding fertilizer, insecticide & medicines) during April, 2011 valued at Rs. 41,315.01million was higher by 2.92% compared to March, 2011 Rs. 40,144.32 million and by 27.71% compared to April, 2010 Rs. 32,349.80 million. During July – April, 2011 its imports amounted to Rs. 336,795.94million which was higher by 22.44% compared to imports of Rs. 275,061.11 million during the corresponding period of last year.

The share of chemicals (Excluding fertilizer, insecticide & medicines) in total imports in April, 2011 were 15.04% as against 13.77% in March, 2011 and 12.78% in April, 2010. During July – April, 2011 its share was 12.21% as against 11.69% in the corresponding period of last year.

Machinery

Imports of machinery during April, 2011 valued at Rs. 40,446.76million was higher by 11.70% compared to March, 2011 Rs. 36,209.56 million and by 0.04% compared to April, 2010 Rs. 40,431.31million. Cumulative imports of machinery during the period July – April, 2011 amounted to Rs. 380,528.79 million as against Rs. 377,077.25million during the corresponding period of last year showing an increase of 0.92 percent.

The share of machinery in total imports in April, 2011 was 14.72% as against 12.42% in March, 2011 and by 15.97% in April, 2010. During July – April, 2011 its share was 13.79% as against 16.03% in the corresponding period of last year.

Transport Equipment

Transport equipment were Rs. 20,514.31million was imported during April, 2011 as against its imports of Rs. 12,713.10million in March, 2011 and Rs. 15,928.64 million in April, 2010 showing an increase of 61.36% over March, 2011 and by 28.79% over April, 2010. The imports of this item during July – April, 2011 totaled Rs. 147,668.88million which was higher by 8.05% as compared to its imports of Rs. 136,663.62 million during the corresponding period of last year.

The share of transport equipment in total imports in April, 2011 was 7.47% as against 4.36% in March, 2011 and by 6.29% in April, 2010. During July – April, 2011 its share was 5.35% as against the share of 5.81% in the corresponding period of last year.

III - Direction of Imports

Imports by Territories/Regions and major countries during April, 2011 and July – April, 2011 of current financial year compared with the corresponding month and corresponding period of last year are given in table 10, 11, 12 and 13 respectively.

During April, 2011, (13.51%) of total imports were from European Union. The share of imports of Middle East was 28.61 % and North America 7.34 percent. Country-wise, China was at the top of imports list during April, 2011 followed by Saudi Arabia, U.A.E, Malaysia, Kuwait and U.S.A. The combined share of these six countries during April, 2011 was 55.24% as against their combined share of 51.01% during April, 2010.

During July – April, 2011, the share of imports of European Union was 10.65 percent. The share of imports of Middle East was 35.46 % and from North America 6.00% of total imports during this period. Country-wise, China was at the top of the imports list followed by U.A.E, Saudi Arabia, Kuwait, Malaysia and India during July – April, 2011. Combined share of these six countries in total imports during this period was 56.64% as against their combined share of 51.74% during the corresponding period of last year.

IV - Imports by Economic Categories

During April, 2011 imports of consumer goods increased by 2.68% and of raw materials for consumer goods 13.37% compared to April, 2010. Imports of capital goods during April, 2011 increased by 1.68% and raw material for capital goods by 14.87 % compared to the same month of last year.

During July – April, 2011 imports of consumer goods were higher by 47.25% and of raw material for consumer goods by 18.34% compared to July – April, 2010. Imports of capital goods during July – April, 2011 increased by 1.81% and of raw material for capital goods by 17.34% compared to the corresponding period of last year.

Performance of imports by economic categories is shown in table-14.
