TRADE SUMMARY

April-June, 2023

EXPORTS

The total exports of Pakistan during Apr-Jun, 2023 amounted to Rs. 1,910,711.15 million showing an increase of 7.91% over Jan-Mar, 2023 and increased by 16.34% over Apr-Jun, 2022. In terms of US dollar, the export during Apr-Jun, 2023 amounted to \$ 6,687.84 million showing a decrease of 1.54% over Jan-Mar, 2023 and showing a decrease of 20.69% over Apr-Jun, 2022.

Export during Jul-Jun, 2023 totaled Rs. 6,859,225.39 million showing an increase of 21.16% over the corresponding period of last year. While in terms of US dollars, exports stand at \$ 27.724.05 million showing a decrease of 12.77% over the corresponding period of last year.

IMPORTS

The total imports of Pakistan during Apr-Jun, 2023 amounted to Rs. 3,278,605.62 million showing an increase of 1.46% over Jan-Mar, 2023 and decreased by 21.11% over Apr-Jun, 2022. In terms of US dollar, the imports during Apr-Jun, 2023 amounted to \$ 11,474.17 million showing a decrease of 8.32% over Jan-Mar, 2023 and 46.07% over Apr-Jun, 2022.

Import during Jul-Jun, 2023 totaled Rs. 13,472,987.93 million showing a decrease of 5.60% over the corresponding period of last year. In terms of US dollars, Imports stand at stands at \$ 55,198.45 million showing a decrease of 31.12% over the corresponding period of last year.

TOTAL TRADE

The total trade of Pakistan during Apr-Jun, 2023 amounted to Rs. 5,189,316.77 million showing an increase of 3.74% over Jan-Mar, 2023 and decrease by 10.51% over Apr-Jun, 2022. In terms of US dollar, the total trade during Apr-Jun, 2023 amounted to \$18,162.01 million showing a decrease of 5.94% over Jan-Mar, 2023 and 38.87% over Apr-Jun, 2022.

Total trade during Jul-Jun, 2023 totaled Rs. 20,333,181.28 million showing an increase of 2.00% over the corresponding period of last year. In terms of US dollars, total trade stands at \$ 82,925.89 million showing a decrease of 25.91%.

BALANCE OF TRADE

Balance of trade in Apr-Jun, 2023 was unfavorable to Pakistan to the tune of Rs. 1,367,894.47 million equivalents to US \$4,786.33 million, whereas during the period of Jul-Jun, 2023 it was unfavorable to the tune of 6,613,761.61 million rupees equivalent to US \$22,474.40 million.






CHAPTER-I

1.1– EXPORT BY GROUP/COMMODITIES

Food Group

During Apr-Jun, 2023 export of goods belonging to Food Group decreased by 9.00% over Jan-Mar, 2023 and 19.54% over Apr-Jun, 2022. Food Group contributed 12.50% of total exports.

The export of food group during Jul-Jun, 2023 increased by 21.80% compared to the same period of last year. This Group contributed 12.12% of total export during Jul-Jun, 2023.

Textile Group

During Apr-Jun, 2023 export of Textile goods increased by 18.56% over Jan-Mar, 2023 and increased by 15.80% over Apr-Jun, 2022. Textile Group contributed 57.53% of total exports.

The export of textile group increased by 17.99% for the period of Jul-Jun, 2023 compared to the same period of last year. Textile Group contributed 56.62% of total exports during Jul-Jun, 2023.

Manufactures Group

During Apr-Jun, 2023 export of manufactured goods increased by 7.69% over Jan-Mar, 2023 and by 28.93% over Apr-Jun, 2022. Manufactures Group contributed 6.71% of total exports.

Export for manufacture group during Jul-Jun, 2023 increased by 36.83% compared to the same period of last year. Manufacture Group contributed 6.86% of total exports during Jul-Jun, 2023.

1.2– DIRECTION OF EXPORTS

During Apr-Jun, 2023 country-wise U. S. A. was at the top of the export list followed by China, United Kingdom, Netherlands, Germany, Spain, Italy, United Arab Emirates, Afghanistan and Belgium. The share of these ten countries in total exports for Apr-Jun, 2023 was 66.27% as against 66.03% in Apr-Jun, 2022.

During Jul-Jun, 2023 Country-wise, U.S.A. was at the top of the exports list followed by China, United Kingdom, Netherlands, Germany, Spain, United Arab Emirates, Italy, Afghanistan and Belgium. The share of these ten countries in total exports for Jul-Jun, 2023 was 65.34% as against 66.89% in the same period of last year.

1.3– EXPORT BY ECONOMIC CATEGORIES

Export of Primary Commodities during Apr-Jun, 2023 increased by 7.55%, Semi- Manufactures increased by 37.04% and Manufactured Goods increased by 16.47% over Apr-Jun, 2022. Whereas, their share in total export stands at 15.25%, 7.66% and 77.08% respectively for Apr-Jun, 2023.

Exports of Primary Commodities during Jul-Jun, 2023 increased by 20.96%, Semi-Manufactures increased by 20.44% and Manufactured Goods increased by 21.27%. Whereas, their respective share in total export for the period of Jul-Jun, 2023 stood at 15.97%, 6.61% and 77.42%.

CHAPTER-2

2.1 – IMPORTS BY GROUPS/COMMODITIES

Food Group

During Apr-Jun, 2023 import of goods belonging to Food Group decreased by 3.14% over Jan-Mar, 2023 and increased by 38.03% over Apr-Jun, 2022. This group contributed 9.90% of total imports.

The import of food group during Jul-Jun, 2023 increased by 50.87% compared to the same period of last year. This group contributed 10.13% of total imports during Jul-Jun, 2023.

Machinery & Transport Group

During Apr-Jun, 2023 import of goods belonging to Machinery & Transport group increased by 5.08% over Jan-Mar, 2022 and decreased by 31.61% over Apr-Jun, 2022. This group contributed 13.38% of total imports.

The import of goods belonging to Machinery & Transport group during Jul-Jun, 2023 decreased by 32.19% compared to the same period of last year. This group contributed 13.58% of total import during Jul-Jun, 2023.

Petroleum Group

During Apr-Jun, 2023 import of goods belonging to Petroleum group increased by 16.92% over Jan-Mar, 2022 and decreased by 37.39% over Apr-Jun, 2022. This group contributed 25.10% of total imports.

The import of petroleum group during Jul-Jun, 2023 decreased by 3.69% compared to the same period of last year. This group contributed 22.89% of total imports during Jul-Jun, 2023.

Textile Group

During Apr-Jun, 2023 import of goods belonging to textile group increased by 33.75% over Jan-Mar 2023 and decreased by 6.50% over Apr-Jun, 2022. This group contributed 2.27% of total imports.

The import of Textile group during Jul-Jun, 2023 decreased by 9.27% compared to the same period of last year. This group contributed 1.93% of total imports during Jul-Jun, 2023.

Chemical Group

During Apr-Jun, 2023 import of goods belonging to Chemical group increased by 17.04% over Jan-Mar, 2023 and decreased by 5.32% over Apr-Jun, 2022. This group contributed 16.84% of total imports.

The import of chemical group during Jul-Jun, 2023 decreased by 12.75% compared to the same period of last year. This group contributed 16.16% of total imports during Jul-Jun, 2023.

Metal Group

During Apr-Jun, 2023 import of Metal products decreased by 12.19% over Jan-Mar, 2023 and decreased by 29.72% over Apr-Jun, 2022. This group contributed 5.03% of total imports.

The import of metal group during Jul-Jun, 2023 decreased by 20.59% compared to the same period of last year. This group contributed 5.48% of total imports during Jul-Jun, 2023.

Miscellaneous Group

During Apr-Jun, 2023 imports of miscellaneous commodities decreased by 2.17% over Jan-Mar, 2023 and 18.81% over Apr-Jun, 2022. This group contributed 0.84% of total imports.

The import of miscellaneous group during Jul-Jun, 2023 decreased by 4.87% compared to the same period of last year. This group contributed 0.93% of total imports during Jul-Jun, 2023.

2.2– DIRECTION OF IMPORTS

During Apr-Jun, 2023 Country-wise China was at the top of the import list for Apr-Jun, 2023 followed by United Arab Emirates, Saudi Arabia, Indonesia, Qatar, U.S.A., Kuwait, Russian Federation, Singapore and Canada. The share of these ten countries in total imports for Apr-Jun, 2023 was 71.09% as against 70.26% in Apr-Jun, 2022.

During Jul-Jun, 2023 Country-wise China was on the top of the import list followed by United Arab Emirates, Indonesia, Saudi Arabia, Qatar, U.S.A, Kuwait, Japan, Singapore and Thailand. The combined share of these ten countries in total imports during this period was 67.49% as against their combined share of 69.24% during the corresponding period of last year.

2.3– IMPORTS BY BROAD ECONOMIC CATEGORIES

Imports of Consumer Goods/Intermediate Goods during Apr-Jun, 2023 decreased by 36.95%, Consumer Goods decreased by 25.58%, Consumer Goods/Capital Goods decreased by 33.56%, Intermediate Goods decreased by 9.69%, Intermediate Goods/Capital Goods increased by 3.68%, Intermediate Goods/Consumer Goods increased by 4.25%, Capital Goods decreases by 33.61, Capital Goods/Consumer Goods decreased by 0.19% and Capital Goods/Intermediate Goods decreased by 35.04% over Apr-Jun, 2022. Their respective share in total imports were 25.85%, 7.10%, 0.13%, 57.90%, 0.06%, 2.42%, 5.89%, 0.63% and 0.03% respectively for Apr-Jun, 2023.

Imports of Consumer Goods/Intermediate Goods during Jul-Jun, 2023 decreased by 7.07%, Consumer Goods decreased by 19.40%, Consumer Goods/Capital Goods decreased by 26.32%, Intermediate Goods increased by 1.31%, Intermediate Goods/Capital Goods decreased by 23.19%, Intermediate Goods/Consumer Goods increased by 9.32%, Capital Goods decreases by 31.82%, Capital Goods/Consumer Goods decreased by 21.87% and Capital Goods/Intermediate Goods decreased by 21.76% over Apr-Jun, 2022. Their respective share in total imports were 23.37%, 7.89%, 0.14%, 59.14%, 0.05%, 2.40%, 6.47%, 0.50% and 0.04% respectively for FY2023.
