# TRADE SUMMARY January-March, 2020

## **EXPORTS**

The total exports of Pakistan during Jan-Mar, 2020 amounted to Rs. 921,435.12 million showing a decrease of 1.42% over Oct-Dec, 2019 but increased by 12.71% over Jan-Mar, 2019.

In terms of US dollar, the exports during Jan-Mar, 2020 amounted to \$ 5,919.01 million showing an increase of 7.43% over Oct-Dec, 2019 and by 0.49% over Jan-Mar, 2019.

Exports during Jul-Mar, 2020 totaled Rs. 2,725,210.42 million showing an increase of 20.39% over the corresponding period of last year. In terms of US dollars, exports stand at \$17,443.28 million showing an increase of 2.18% over the corresponding period of last year.

#### **IMPORTS**

The total imports of Pakistan during Jan-Mar, 2020 amounted to Rs. 1,804,296.04 million showing a decrease of 3.22% over Oct-Dec, 2019 but increased by 2.14% over Jan-Mar, 2019.

In terms of US dollar, the imports during Jan-Mar, 2020 amounted to \$ 11,596.00 million showing an increase of 3.54% over Oct-Dec, 2019 but decreased by 8.89% over Jan-Mar, 2019.

Imports during Jul-Mar, 2020 totaled Rs. 5,434,523.99 million showing an increase of 1.18% over the corresponding period of last year. In terms of US dollars, Imports stand at stands at \$34,790.60 million showing a decrease of 14.48% over the corresponding period of last year.

#### **TOTAL TRADE**

The total trade of Pakistan during Jan-Mar, 2020 amounted to Rs. 2,725,731.16 million showing a decrease of 2.62% over Oct-Dec, 2019 but increased by 5.49% over Jan-Mar, 2019.

In terms of US dollars, the total trade during Jan-Mar, 2020 amounted to \$ 17,515.01 million showing an increase of 4.82% over Oct-Dec, 2019 but decreased by 5.92% over Jan-Mar, 2019.

Total trade during Jul-Mar, 2020 totaled Rs. 8,159,734.41 million showing an increase of 6.87% over the corresponding period of last year. In terms of US dollars, total trade stands at \$52,233.88 million showing a decrease of 9.55%.

# **BALANCE OF TRADE**

Balance of trade in Jan-Mar, 2020 was unfavorable to Pakistan to the tune of Rs. 882,860.92 million equivalents to US \$ 5,676.99 million, whereas during the period of Jul-Mar, 2020 it was unfavorable to the tune of 2,709,313.57 million rupees equivalent to US \$ 17,347.32 million.



# **I – EXPORTS BY GROUP/COMMODITIES**

# **Food Group**

During Jan-Mar, 2020 exports of goods belonging to Food Group increased by 5.48% over Oct-Dec, 2019 and by 6.44% over Jan-Mar, 2019. Food Group contributed 16.21 of total exports during Jan-Mar, 2020.

The exports of food group during Jul-Mar, 2020 increased by 27.69% compared to the same period of last year. This Group contributed 14.77% of total exports during Jul-Mar, 2020.

# **Textile Group**

During Jan-Mar, 2020 exports of Textile goods increased by 0.59% over Oct-Dec, 2019 and by 15.12% over Jan-Mar, 2019. Textile Group contributed 54.15% of total exports during Oct-Dec, 2019.

The exports of textile group increased by 22.42% for the period of Jul-Mar, 2020 compared to the same period of last year. Textile Group contributed 57.53% of total exports during Jul-Mar, 2020.

# **Manufacture Group**

During Jan-Mar, 2020 exports of manufacture goods decreased by 7.37% over Oct-Dec, 2019 but increased by 14.01% over Jan-Mar, 2019. Manufactures Group contributed 7.09% of total exports during Jan-Mar, 2020.

Exports for manufacture group during Jul-Mar, 2020 increased by 15.89% compared to the same period of last year. Manufacture Group contributed 7.55% of total exports during Jul-Mar, 2020.

## II – DIRECTION OF EXPORTS

During the quarter of Jan-Mar, 2020, the share of European Union in total exports was 34.70% as against 33.66% in Jan-Mar, 2019. The share of Other Asia in total exports was 23.01% as against 29.40% in Jan-Mar, 2019. The share of North America during Jan-Mar, 2020 was 18.12% as against 17.88% in Jan-Mar, 2019. The share of Middle East during Jan-Mar, 2020 was 13.09% as against 9.20% in Jan-Mar, 2019. The share of Other Africa during Jan-Mar, 2020 was 6.01% as against 5.23% in Jan-Mar, 2019. Country-wise U. S. A. was at the top of the exports list for Jan-Mar, 2020 followed by China, United Kingdom, Germany, United Arab Emirates and Netherlands. The share of these six countries in total exports for Jan-Ma, 2020 was 47.59% as against 45.12% in Jan-Mar, 2019.

During Jul-Mar, 2020 the share of European Union in total exports increased to 34.78% from 34.11% during the same period of last year. The share of Other Asia in total exports decreased to 24.23% from 28.33% during the same period of last year. The share of North America increased to 18.51% from 18.18% during the same period of last year. The share of Middle East increased to 12.34% from 9.18% during the same period of last year. The share of Other Africa increased to 5.59% from 5.39% during the same period of last year.

Country-wise, U.S.A. was at the top of the exports list for Jul-Mar, 2020 followed by China, United Kingdom, Germany, United Arab Emirates and Netherlands. The share of these six countries in total exports for Jul-Mar, 2020 was 48.41% as against 45.60% in the same period of last year.

# **III – EXPORTS BY ECONOMIC CATEGORIES**

Exports of Primary Commodities during Jan-Mar, 2020 increased by 1.57%, Semi-Manufactures decreased by 7.02% and Manufactured Goods increased by 18.72% over Oct-Dec, 2019. Whereas, their share in total exports stands at 18.79%, 7.80% and 73.41% respectively.

Exports of Primary Commodities during Jul-Mar, 2020 increased by 17.71%, Semi-Manufactures by 7.96% and Manufactured Goods by 22.67%. Whereas, their respective share in total exports for the period of Jul-Mar, 2020 stood at 17.76%, 8.41% and 73.83%.

# I – IMPORTS BY GROUPS/COMMODITIES

#### **Food Group**

During Jan-Mar, 2020 imports of goods belonging to Food Group increased by 16.80% over Oct-Dec, 2019 and by 28.81% over Jan-Mar, 2019. This group contributed 7.87% of total imports during Jan-Mar, 2020.

The imports of food group during Jul-Mar, 2020 increased by 12.27% compared to the same period of last year. This contributed 6.71% of total imports during Jul-Mar, 2020.

# **Machinery & Transport Group**

During Jan-Mar, 2020 imports of goods belonging to Machinery & Transport group decreased by 5.06% over Oct-Dec, 2019 but increased by 2.37% over Jan-Mar, 2019. This group contributed 21.97% of total imports during Jan-Mar, 2020.

The imports of goods belonging to Machinery & Transport group during Jul-Mar, 2020 decreased by 5.44% compared to the same period of last year. This group contributed 22.39% of total imports during Jul-Mar, 2020.

## **Petroleum Group**

During Jan-Mar, 2020 imports of goods belonging to Petroleum group decreased by 7.45% over Oct-Dec, 2019 but increased by 6.43% over Jan-Mar, 2019. This group contributed 17.69% of total imports during Jan-Mar, 2020.

The imports of petroleum group during Jul-Mar, 2020 decreased by 4.94% compared to the same period of last year. This group contributed 18.44% of total imports during Jul-Mar, 2020.

## **Textile Group**

During Jan-Mar, 2020 imports of goods belonging to Textile group increased by 2.58% over Oct-Dec, 2019 but decreased by 5.45% over Jan-Mar, 2019. This group contributed 2.34% of total imports during Jan-Mar, 2020.

The imports of Textile group during Jul-Mar, 2020 decreased by 0.72% compared to the same period of last year. This group contributed 2.21% of total imports during Jul-Mar, 2020.

# **Chemical Group**

During Jan-Mar, 2020 imports of goods belonging to Chemical group decreased by 12.46% over Oct-Dec, 2019 and by 1.29% over Jan-Mar, 2019. This group contributed 15.19% of total imports during Jan-Mar, 2020.

The imports of chemical group during Jul-Mar, 2020 increased by 0.42% compared to the same period of last year. This group contributed 16.08% of total imports during Jul-Mar, 2020.

# **Metal Group**

During Jan-Mar, 2020 imports of Metal products decreased by 3.83% over Oct-Dec, 2019 and by 0.36% over Jan-Mar, 2019. This group contributed 6.71% of total imports during Jan-Mar, 2020.

The imports of metal group during Jul-Mar, 2020 increased by 0.53% compared to the same period of last year. This group contributed 6.75% of total imports during Jul-Mar, 2020.

# **Miscellaneous Group**

During Jan-Mar, 2020 imports of miscellaneous commodities decreased by 3.88% over Oct-Dec, 2019 and by 17.50% over Jan-Mar, 2019. This group contributed 1.04% of total imports.

The imports of miscellaneous group during Jul-Mar, 2020 decreased by 14.40% compared to the same period of last year. This group contributed 1.11% of total imports during Jul-Mar, 2020.

# **II – DIRECTION OF IMPORTS**

During Jan-Mar, 2020, the share of Other Asia in total imports was 45.29% as against 47.41% in Jan-Mar, 2019. The share of Middle East during Jan-Mar, 2020 was 26.67% as against 26.60% in Jan-Mar, 2019. The share of European Union during Jan-Mar, 2020 was 10.08% as against 10.95% in Jan-Mar, 2019. Country-wise China was at the top of the imports list for Jan-Mar, 2020 followed by United Arab Emirates, U. S. A., Indonesia, Saudi Arabia and Qatar. The share of these six countries in total imports for Jan-Mar, 2020 was 56.96% as against 56.29% in Jan-Mar, 2019.

During Jul-Mar, 2020 the share of Other Asia in total imports increased to 45.36% from 45.42% during the same period of last year. The share of Middle East decreased to 27.91% from 29.65% during the same period of last year. The share of European Union increased to 10.63% from 10.34% during the same period of last year.

Country-wise China was on the top of the imports list followed by United Arab Emirates, U.S.A., Indonesia, Saudi Arabia and Qatar during Jul-Mar, 2020. The combined share of these six countries in total imports during this period was 57.13% as against their combined share of 56.96% during the corresponding period of last year.

# **III – IMPORTS BY ECONOMIC CATEGORIES**

Imports of Consumer Goods during Jan-Mar, 2020 increased by 9.26%, Raw Material for Consumer Goods increased by 2.37%, Capital Goods decreased by 1.76% and Raw Material for Capital Goods decreased by 0.02% over Jan-Mar, 2019. Their respective share in total imports were 18.65%, 43.45%, 27.14% and 10.76% respectively for Jan-Mar, 2020.

Imports of Consumer Goods during Jul-Mar, 2020 increased by 3.55%, Raw Material for Consumer Goods decreased by 1.25%, Capital Goods increased by 2.62% and Raw Material for Capital Goods increased by 3.52% over Jul-Mar, 2019. Their respective share in total imports were 18.56%, 42.94%, 27.76% and 10.74% respectively for Jul-Mar, 2020.
