TRADE SUMMARY October-December, 2019

EXPORTS

The total exports of Pakistan during Oct-Dec, 2019 amounted to Rs. 934,745.64 million showing an increase of 7.56% over Jul-Sep, 2019 and 19.92% over Oct-Dec, 2018.

In terms of US dollar, the export during Oct-Dec, 2019 amounted to \$ 6,014.52 million showing an increase of 9.16% over Jul-Sep, 2019 and by 3.57% over Oct-Dec, 2018.

Export during Jul-Dec, 2019 totaled Rs. 1,803,775.30 million showing an increase of 24.73% over the corresponding period of last year. In terms of US dollars, exports stand at \$ 11,524.27 million showing an increase of 3.07% over the corresponding period of last year.

IMPORTS

The total imports of Pakistan during Oct-Dec, 2019 amounted to Rs. 1,864,255.82 million showing an increase of 5.57% over Jul-Sep, 2019 and by 0.92% over Oct-Dec, 2018.

In terms of US dollar, the imports during Oct-Dec, 2019 amounted to \$ 11,995.41 million showing an increase of 7.11% over Jul-Sep, 2019 but decreased by 13.00% over Oct-Dec, 2018.

Import during Jul-Dec, 2019 totaled Rs. 3,630,227.95 million showing an increase of 0.71% over the corresponding period of last year. In terms of US dollars, Imports stand at stands at \$23,194.60 million showing a decrease of 17.02% over the corresponding period of last year.

TOTAL TRADE

The total trade of Pakistan during Oct-Dec, 2019 amounted to Rs. 2,799,001.46 million showing an increase of 6.22% over Jul-Sep, 2019 and by 6.56% over Oct-Dec, 2018.

In terms of US dollars, the total trade during Oct-Dec, 2019 amounted to \$ 18,009.93 million showing an increase of 7.79% over Jul-Sep, 2019 but decreased by 8.09% over Oct-Dec, 2018.

Total trade during Jul-Dec, 2019 totaled Rs. 5,434,003.25 million showing an increase of 7.59% over the corresponding period of last year. In terms of US dollars, total trade stands at \$34,718.87 million showing a decrease of 11.28%.

BALANCE OF TRADE


Balance of trade in Oct-Dec, 2019 was unfavorable to Pakistan to the tune of Rs. 929,510.18 million equivalents to US \$ 5,980.89 million, whereas during the period of Jul-Dec, 2019 it was unfavorable to the tune of 1,826,452.65 million rupees equivalent to US \$ 11,670.33 million.







I – EXPORT BY GROUP/COMMODITIES

Food Group

During Oct-Dec, 2019 export of goods belonging to Food Group increased by 27.04% over Jul-Sep, 2019 and by 28.07% over Oct-Dec, 2018. Food Group contributed 15.15% of total exports during Oct-Dec, 2019.

The export of food group during Jul-Dec, 2019 increased by 44.72% compared to the same period of last year. This Group contributed 14.03% of total export during Jul-Dec, 2019.

Textile Group

During Oct-Dec, 2019 export of Textile goods increased by 2.32% over Jul-Sep, 2019 and by 20.86% over Oct-Dec, 2018. Textile Group contributed 56.58% of total exports during Oct-Dec, 2019.

The export of textile group increased by 25.90% for the period of Jul-Dec, 2019 compared to the same period of last year. Textile Group contributed 57.97% of total exports during Jul-Dec, 2019.

Manufacture Group

During Oct-Dec, 2019 export of manufacture goods increased by 0.82% over Jul-Sep, 2019 and by 11.49% over Oct-Dec, 2018. Manufactures Group contributed 7.55% of total exports during Oct-Dec, 2019.

Export for manufacture group during Jul-Dec, 2019 increased by 16.79% compared to the same period of last year. Manufacture Group contributed 7.79% of total exports during Jul-Dec, 2019.

II – DIRECTION OF EXPORTS

During the quarter of Oct-Dec, 2019, the share of European Union in total exports was 34.13% as against 34.24% in Oct-Dec, 2018. The share of Other Asia in total exports was 25.90% as against 28.37% in Oct-Dec, 2018. The share of North America during Oct-Dec, 2019 was 18.18% as against 17.92% in Oct-Dec, 2018. The share of Middle East during Oct-Dec, 2019 was 11.84% as against 8.31% in Oct-Dec, 2018. The share of Other Africa during Oct-Dec, 2019 was 5.66% as against 5.87% in Oct-Dec, 2018. Country-wise U. S. A. was at the top of the export list for Oct-Dec, 2019 followed by China, United Kingdom, Germany, United Arab Emirates and Afghanistan. The share of these six countries in total exports for Oct-Dec, 2019 was 48.67% as against 46.61% in Oct-Dec, 2018.

During Jul-Dec, 2019 the share of European Union in total exports increased to 34.81% from 34.36% during the same period of last year. The share of Other Asia in total exports decreased to 24.85% from 27.72% during the same period of last year. The share of North America increased to 18.71% from 18.35% during the same period of last year. The share of Middle East increased to 11.96% from 9.16% during the same period of last year. The share of Other Africa decreased to 5.37% from 5.49% during the same period of last year.

Country-wise, U.S.A. was at the top of the exports list for Jul-Dec, 2019 followed by China, United Kingdom, Germany, United Arab Emirates and Netherlands. The share of these six countries in total exports for Jul-Dec, 2019 was 48.82% as against 45.86% in the same period of last year.

III – EXPORT BY ECONOMIC CATEGORIES

Export of Primary Commodities during Oct-Dec, 2019 increased by 21.37%, Semi-Manufactures by 16.13% and Manufactured Goods by 19.98% over Jul-Sep, 2019. Whereas, their share in total export stands at 18.51%, 7.96% and 73.53% respectively.

Exports of Primary Commodities during Jul-Dec, 2019 increased by 29.14%, Semi-Manufactures by 16.55% and Manufactured Goods by 24.77%. Whereas, their respective share in total export for the period of Jul-Dec, 2019 stood at 17.23%, 8.72% and 74.05%.

I – IMPORT BY GROUPS/COMMODITIES

Food Group

During Oct-Dec, 2019 import of goods belonging to Food Group increased by 20.31% over Jul-Sep, 2019 and by 12.32% over Oct-Dec, 2018. This group contributed 6.52% of total imports during Oct-Dec, 2019.

The import of food group during Jul-Dec, 2019 increased by 3.77% compared to the same period of last year. This contributed 6.13% of total imports during Jul-Dec, 2019.

Machinery & Transport Group

During Oct-Dec, 2019 import of goods belonging to Machinery & Transport group increased by 3.64% over Jul-Sep, 2019 and by 7.82% over Oct-Dec, 2018. This group contributed 22.39% of total imports during Oct-Dec, 2019.

The import of goods belonging to Machinery & Transport group during Jul-Dec, 2019 increased by 6.98% compared to the same period of last year. This group contributed 22.60% of total import during Jul-Dec, 2019.

Petroleum Group

During Oct-Dec, 2019 import of goods belonging to Petroleum group increased by 2.09% over Jul-Sep, 2019 but decreased by 15.27% over Oct-Dec, 2018. This group contributed 18.50% of total imports during Oct-Dec, 2019.

The import of petroleum group during Jul-Dec, 2019 decreased by 9.46% compared to the same period of last year. This group contributed 18.81% of total imports during Jul-Dec, 2019.

Textile Group

During Oct-Dec, 2019 import of goods belonging to Textile group increased by 12.23% over Jul-Sep 2019 and by 4.86% over Oct-Dec, 2018. This group contributed 2.21% of total imports during Oct-Dec, 2019.

The import of Textile group during Jul-Dec, 2019 increased by 2.06% compared to the same period of last year. This group contributed 2.14% of total imports during Jul-Dec, 2019.

Chemical Group

During Oct-Dec, 2019 import of goods belonging to Chemical group increased by 9.15% over Jul-Sep, 2019 and by 3.10% over Oct-Dec, 2018. This group contributed 16.79% of total imports during Oct-Dec, 2019.

The import of chemical group during Jul-Dec, 2019 increased by 1.21% compared to the same period of last year. This group contributed 16.52% of total imports during Jul-Dec, 2019.

Metal Group

During Oct-Dec, 2019 import of Metal products increased by 5.16% over Jul-Sep, 2019 and by 4.10% over Oct-Dec, 2018. This group contributed 6.76% of total imports during Oct-Dec, 2019.

The import of metal group during Jul-Dec, 2019 increased by 0.98% compared to the same period of last year. This group contributed 6.77% of total imports during Jul-Dec, 2019.

Miscellaneous Group

During Oct-Dec, 2019 imports of miscellaneous commodities decreased by 10.19% over Jul-Sep, 2019 and by 17.07% over Oct-Dec, 2018. This group contributed 1.05% of total imports.

The import of miscellaneous group during Jul-Dec, 2019 decreased by 12.91% compared to the same period of last year. This group contributed 1.14% of total imports during Jul-Dec, 2019.

II – DIRECTION OF IMPORTS

During Oct-Dec, 2019, the share of Other Asia in total imports was 45.35% as against 43.92% in Oct-Dec, 2018. The share of Middle East during Oct-Dec, 2019 was 27.05% as against 32.25% in Oct-Dec, 2018. The share of European Union during Oct-Dec, 2019 was 11.14% as against 9.71% in Oct-Dec, 2018. Country-wise China was at the top of the import list for Oct-Dec, 2019 followed by United Arab Emirates, U. S. A., Indonesia, Saudi Arabia and Qatar. The share of these six countries in total imports for Oct-Dec, 2019 was 59.30% as against 58.22% in Oct-Dec, 2018.

During Jul-Dec, 2019 the share of Other Asia in total imports increased to 45.39% from 44.45% during the same period of last year. The share of Middle East decreased to 28.53% from 31.14% during the same period of last year. The share of European Union increased to 10.90% from 10.04% during the same period of last year.

Country-wise China was on the top of the import list followed by United Arab Emirates, U.S.A., Saudi Arabia, Indonesia and Qatar during Jul-Dec, 2019. The combined share of these six countries in total imports during this period was 57.21% as against their combined share of 57.29% during the corresponding period of last year.

III – IMPORTS BY ECONOMIC CATEGORIES

Imports of Consumer Goods during Oct-Dec, 2019 decreased by 3.07%, Raw Material for Consumer Goods decreased by 3.71%, Capital Goods increased by 5.66% and Raw Material for Capital Goods increased by 17.53% over Oct-Dec, 2018. Their respective share in total imports were 18.27%, 42.89%, 27.75% and 11.09% respectively for Oct-Dec, 2019.

Imports of Consumer Goods during Jul-Dec, 2019 increased by 0.91%, Raw Material for Consumer Goods decreased by 2.98%, Capital Goods increased by 4.86% and Raw Material for Capital Goods increased by 5.38% over Jul-Dec, 2018. Their respective share in total imports were 18.51%, 42.70%, 28.07% and 10.73% respectively for Jul-Dec, 2019.
