#### TRADE SUMMARY October-December, 2021

#### **EXPORTS**

The total exports of Pakistan during Oct-Dec, 2021 amounted to Rs. 1,414,710.95 million showing an increase of 23.33% over Jul-Sep, 2021 and 32.65% over Oct-Dec, 2020.

In terms of US dollar, the export during Oct-Dec, 2021 amounted to \$ 8,128.97 million showing an increase of 22.85% over Jul-Sep, 2021 and by 22.46% over Oct-Dec, 2020.

Export during Jul-Dec, 2021 totaled Rs. 2,561,783.89 million showing an increase of 29.46% over the corresponding period of last year. In terms of US dollars, exports stand at \$ 15,125.1 million showing an increase of 24.90% over the corresponding period of last year.

#### **IMPORTS**

The total imports of Pakistan during Oct-Dec, 2021 amounted to Rs. 3,803,164.34 million showing an increase of 23.80% over Jul-Sep, 2021 and by 79.84% over Oct-Dec, 2020.

In terms of US dollar, the imports during Oct-Dec, 2021 amounted to \$ 21,847.56 million showing an increase of 29.35% over Jul-Sep, 2021 and by 65.91% over Oct-Dec, 2020.

Import during Jul-Dec, 2021 totaled Rs. 6,875,212.18 million showing an increase of 72.05% over the corresponding period of last year. In terms of US dollars, Imports stand at stands at \$40,562.69 million showing an increase of 65.87% over the corresponding period of last year.

#### TOTAL TRADE

The total trade of Pakistan during Oct-Dec, 2021 amounted to Rs. 5,217,875.29 million showing an increase of 23.67% over Jul-Sep, 2021 and by 64.02% over Oct-Dec, 2020.

In terms of US dollars, the total trade during Oct-Dec, 2021 amounted to \$ 19,806.32 million showing an increase of 27.52% over Jul-Sep, 2021 and by 51.35% over Oct-Dec, 2020.

Total trade during Jul-Dec, 2021 totaled Rs. 9,436,996.07 million showing an increase of 57.94% over the corresponding period of last year. In terms of US dollars, total trade stands at \$55,687.79 million showing an increase of 52.30%.

#### **BALANCE OF TRADE**

Balance of trade in Oct-Dec, 2021 was unfavorable to Pakistan to the tune of Rs. 2,388,453.39 million equivalents to US \$ 13,718.59 million, whereas during the period of Jul-Dec, 2021 it was unfavorable to the tune of 4,313,428.29 million rupees equivalent to US \$ 25,437.58 million.



#### I – EXPORT BY GROUP/COMMODITIES

#### Food Group

During Oct-Dec, 2021 export of goods belonging to Food Group increased by 66.45% over Jul-Sep, 2021 and by 18.07% over Oct-Dec, 2020. Food Group contributed 12.59% of total exports during Oct-Dec, 2021.

The export of food group during Jul-Dec, 2021 increased by 15.08% compared to the same period of last year. This Group contributed 11.13% of total export during Jul-Dec, 2021.

#### Textile Group

During Oct-Dec, 2021 export of Textile goods increased by 19.23% over Jul-Sep, 2021 and by 35.07% over Oct-Dec, 2020. Textile Group contributed 58.34% of total exports during Oct-Dec, 2021.

The export of textile group increased by 30.26% for the period of Jul-Dec, 2021 compared to the same period of last year. Textile Group contributed 59.24% of total exports during Jul-Dec, 2021.

#### Manufacture Group

During Oct-Dec, 2021 export of manufacture goods increased by 15.86% over Jul-Sep, 2021 and by 20.38% over Oct-Dec, 2020. Manufactures Group contributed 5.87% of total exports during Oct-Dec, 2021.

Export for manufacture group during Jul-Dec, 2021 increased by 10.23% compared to the same period of last year. Manufacture Group contributed 6.04% of total exports during Jul-Dec, 2021.

#### **II – DIRECTION OF EXPORTS**

During the quarter of Oct-Dec, 2021, the share of European Union in total exports was 32.47% as against 35.75% in Oct-Dec, 2020. The share of Other Asia in total exports was 25.81% as against 25.25% in Oct-Dec, 2020. The share of North America during Oct-Dec, 2021 was 23.69% as against 20.51% in Oct-Dec, 2020. The share of Middle East during Oct-Dec, 2021 was 9.46% as against 9.46% in Oct-Dec, 2020. The share of Other Africa during Oct-Dec, 2021 was 4.00% as against 4.59% in Oct-Dec, 2020. Country-wise U. S. A. was at the top of the export list for Oct-Dec, 2021 followed by China, United Kingdom, Germany, Netherlands and United Arab Emirates. The share of these six countries in total exports for Oct-Dec, 2021 was 55.72% as against 54.12% in Oct-Dec, 2020.

During Jul-Dec, 2021 the share of European Union in total exports decreased to 33.84% from 36.69% during the same period of last year. The share of Other Asia in total exports increased to 24.77% from 23.14% during the same period of last year. The share of North America increased to 23.12% from 21.24% during the same period of last year. The share of Middle East decreased to 9.52% from 10.04% during the same period of last year. The share of Other Africa slightly decreased to 4.21% from 4.66% during the same period of last year.

Country-wise, U.S.A. was at the top of the exports list for Jul-Dec, 2021 followed by United States of America, China, United Kingdom, Germany, Netherlands and United Arab Emirates. The share of these six countries in total exports for Jul-Dec, 2021 was 54.79% as against 53.16% in the same period of last year.

#### **III – EXPORT BY ECONOMIC CATEGORIES**

Export of Primary Commodities during Oct-Dec, 2021 decreased by 31.52%, Semi-Manufactures increased by 33.98% and Manufactured Goods increased by 32.79% over Jul-Sep, 2021. Whereas, their share in total export stands at 16.54%, 6.52% and 76.94% respectively.

Exports of Primary Commodities during Jul-Dec, 2021 increased by 33.83%, Semi-Manufactures by 38.22% and Manufactured Goods decreased by 27.95%. Whereas, their respective share in total export for the period of Jul-Dec, 2021 stood at 15.25%, 6.72% and 78.03%.

#### I – IMPORT BY GROUPS/COMMODITIES

#### Food Group

During Oct-Dec, 2021 import of goods belonging to Food Group increased by 3.47% over Jul-Sep, 2021 and increased by 59.40% over Oct-Dec, 2020. This group contributed 5.87% of total imports during Oct-Dec, 2021.

The import of food group during Jul-Dec, 2021 increased by 47.93% compared to the same period of last year. This contributed 6.38% of total imports during Jul-Dec, 2021.

#### Machinery & Transport Group

During Oct-Dec, 2021 import of goods belonging to Machinery & Transport group increased by 14.82% over Jul-Sep, 2021 and by 62.80% over Oct-Dec, 2020. This group contributed 19.48% of total imports during Oct-Dec, 2021.

The import of goods belonging to Machinery & Transport group during Jul-Dec, 2021 increased by 58.81% compared to the same period of last year. This group contributed 20.16% of total import during Jul-Dec, 2021.

#### Petroleum Group

During Oct-Dec, 2021 import of goods belonging to Petroleum group increased by 24.81% over Jul-Sep, 2021 and by 161.15% over Oct-Dec, 2020. This group contributed 18.46% of total imports during Oct-Dec, 2021.

The import of petroleum group during Jul-Dec, 2021 increased by 121.04% compared to the same period of last year. This group contributed 14.32% of total imports during Jul-Dec, 2021.

#### Textile Group

During Oct-Dec, 2021 import of goods belonging to Textile group decreased by 18.38% over Jul-Sep 2021 and increased by 22.21% over Oct-Dec, 2020. This group contributed 1.65% of total imports during Oct-Dec, 2021.

The import of Textile group during Jul-Dec, 2021 increased by 41.97% compared to the same period of last year. This group contributed 2.04% of total imports during Jul-Dec, 2021.

#### **Chemical Group**

During Oct-Dec, 2021 import of goods belonging to Chemical group increased by 40.48% over Jul-Sep, 2021 and by 130.64% over Oct-Dec, 2020. This group contributed 20.76% of total imports during Oct-Dec, 2021.

The import of chemical group during Jul-Dec, 2021 increased by 103.42% compared to the same period of last year. This group contributed 19.66% of total imports during Jul-Dec, 2021.

#### Metal Group

During Oct-Dec, 2021 import of Metal products increased by 36.61% over Jul-Sep, 2021 and by 78.30% over Oct-Dec, 2020. This group contributed 7.14% of total imports during Oct-Dec, 2021.

The import of metal group during Jul-Dec, 2021 increased by 59.06% compared to the same period of last year. This group contributed 6.84% of total imports during Jul-Dec, 2021.

#### Miscellaneous Group

During Oct-Dec, 2021 imports of miscellaneous commodities increased by 9.94% over Jul-Sep, 2021 and decreased by 4.37% over Oct-Dec, 2020. This group contributed 0.92% of total imports.

The import of miscellaneous group during Jul-Dec, 2021 decreased by 1.17% compared to the same period of last year. This group contributed 0.97% of total imports during Jul-Dec, 2021.

#### **II – DIRECTION OF IMPORTS**

During Oct-Dec, 2021, the share of Other Asia in total imports was 48.79% as against 48.21% in Oct-Dec, 2020. The share of Middle East during Oct-Dec, 2021 was 25.12% as against 23.37% in Oct-Dec, 2020. The share of European Union during Oct-Dec, 2021 was 9.04% as against 9.48% in Oct-Dec, 2020. Country-wise China was at the top of the import list for Oct-Dec, 2021 followed by United Arab Emirates, U. S. A., Indonesia, Saudi Arabia and Qatar. The share of these six countries in total imports for Oct-Dec, 2021 was 32.25% as against 29.29% in Oct-Dec, 2020.

During Jul-Dec, 2021 the share of Other Asia in total imports increased to 47.98% from 47.72% during the same period of last year. The share of Middle East increased to 26.56% from 24.19% during the same period of last year. The share of European Union decreased to 8.37% from 10.03% during the same period of last year.

Country-wise China was on the top of the import list followed by United Arab Emirates, Indonesia, Saudi Arabia, U.S.A. and Qatar during Jul-Dec, 2021. The combined share of these six countries in total imports during this period was 58.36% as against their combined share of 54.33% during the corresponding period of last year.

#### **III – IMPORTS BY ECONOMIC CATEGORIES**

Imports of Consumer Goods during Oct-Dec, 2021 increased by 110.48%, Raw Material for Consumer Goods decreased by 77.91%, Capital Goods decreased by 63.45% and Raw Material for Capital Goods decreased by 66.66% over Oct-Dec, 2020. Their respective share in total imports were 25.12%, 40.54%, 23.78% and 10.56% respectively for Oct-Dec, 2021.

Imports of Consumer Goods during Jul-Dec, 2021 increased by 98.52%, Raw Material for Consumer Goods increased by 72.98%, Capital Goods decreased by 58.53% and Raw Material for Capital Goods decreased by 53.97% over Jul-Dec, 2020. Their respective share in total imports were 22.97%, 42.28%, 24.55% and 10.20% respectively for Jul-Dec, 2021.
